

Good morning Mr. Ipri,

Per our conversation this morning, I am able to offer you a reimbursement of \$140.28, which equals the difference between what you paid for electricity supply as a Public Power LLC customer and the rate you would have been charged by PPL for the same duration of time. By accepting this reimbursement, you will be put in substantially the same position you would have been in had you been receiving your electricity supply from PPL.

If you find this a satisfactory resolution to your complaint against Public Power LLC, I will have a check issued to you in the amount of \$25.49, which is the amount of the reimbursement mentioned above, minus the amount you owe Public Power LLC as of September 2, 2014 (\$114.79) for electricity already supplied to you. **Just to be clear, this means that you will not owe Public Power LLC any money, and you will have been charged the PPL rate for the electricity supplied to you.**

To accept this offer, please reply to this email with a statement that: (1) you acknowledge satisfaction of your complaint against Public Power LLC, and (2) that you no longer wish to pursue a complaint against Public Power LLC. This will end your complaint against Public Power LLC, and Public Power LLC will consider the matter closed.



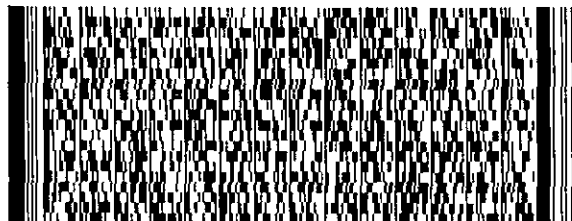

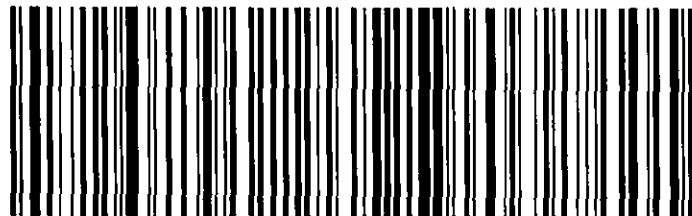
