DOCUMENT

Commonwealth Telephone Company ("CT") and Americell PA-3 L.P. ("Amelicett") R hereby request that the Commission review and approve the attached Interconnection

Agreement pursuant to Sections 252(a)(1) and 252(e) of the Telecommunications Act of 1996

47 U.S.C. §§ 252(a)(1) and 252(e) (the "Agricultation of the Telecommunication of the parties state as follows:

JUN 0 9 2005

- 1. The Agreement was arrived at through good faith negotiations between the parties as contemplated by Section 252(a) of the Act and provides for interconnection as addressed in Section 251 of the Act.
- 2. Pursuant to Section 252(e)(2), the Commission may only reject a negotiated Agreement if it finds that (1) the Agreement discriminates against another carrier or (2) implementation of the Agreement would not be consistent with the public interest, convenience and necessity.
- 3. CT will make the Agreement available to any other telecommunications carrier operating within its territory. Other carriers are also free to negotiate their own terms and

conditions pursuant to the applicable provisions of the Act. For this reason, the Agreement is not discriminatory.

- 4. In addition, implementation of the Agreement is consistent with the public interest because it will promote competition and enhance Americell's ability to provide Pennsylvania telecommunications users with a competitive alternative for Commercial Mobile Radio Services.
- 5. This Agreement is identical in terms to the Verizon Wireless-CTCo Agreement effective February 1, 2003 and approved by the Pennsylvania Public Utility Commission by orders adopted May 1, 2003 and April 17, 2003 (A-313489F7003, A-311255F7003), except that three (3) new definitions and a new Section 6 has been added in order to address FCC number portability requirements.
- 6. In accordance with Section 252(e)(4) of the Act, the Agreement will be deemed approved if the Commission does not act to approve or reject the Agreement within 90 days from the date of this submission.
- 7. Copies of the Agreement are available for public inspection in CT and Americell's public offices.

WHEREFORE, CT and Americell respectfully request that the Commission approve the attached Interconnection Agreement under Section 252(e) of the Act as expeditiously as possible.
