NOW COMES NextEra Energy Services Pennsylvania, LLC, by and through its counsel, Derek Rykaczewski, Esquire, and files the following Motion for Continuance:

1. By Order dated May 7, 2015, this matter was scheduled for Hearing on June 17, 2015 at 10:00 a.m.
2. On June 5, 2015, the parties in this matter resolved this dispute to their mutual satisfaction.
3. On June 8, 2015, Respondent electronically filed with the Commission a Certification of Satisfaction of Complaint indicating that the parties resolved this dispute and requesting that the Complaint be withdrawn pursuant to 52 Pa. Code §5.24(b), and such Certification of Satisfaction of Complaint was accepted for electronic filing by the Commission on June 9, 2015.
4. On June 12, 2015, counsel for each of Complainant and Respondent became aware that they had not filed Notices of Appearance and each entered his appearance on June 12, 2015.

5. Continuance of the hearing in this matter would promote administrative and regulatory efficiency since the parties have resolved this dispute to their mutual satisfaction.

6. Counsel for the Complainant has indicated that he does not oppose such continuance.


