b. **SUMMARY:**


This is a small claims complaint filed against Choice by a pro se petitioner in New Jersey. The petitioner alleges that he contacted Choice to cancel his contract sometime in May, 2014. Petitioner further alleges that he discovered in March, 2015, that Choice never canceled

his contract, per his earlier request, and that he was overcharged as compared to the default service rate offered by his utility. Petitioner was on a variable rate product offered by Choice which did not guarantee any savings compared to the default utility rate.

This matter was resolved amicably and the case is now closed. Attached please find a signed stipulation of dismissal signed by the parties and a copy of the Court's public access system, indicating that the case is settled.

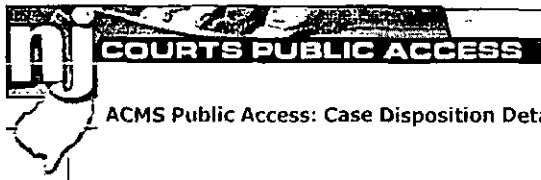

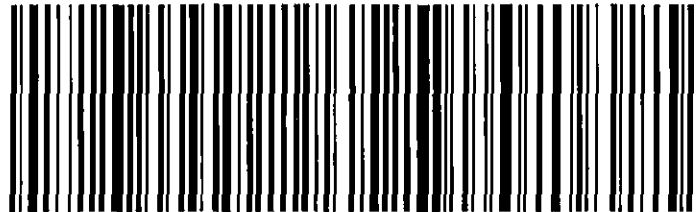
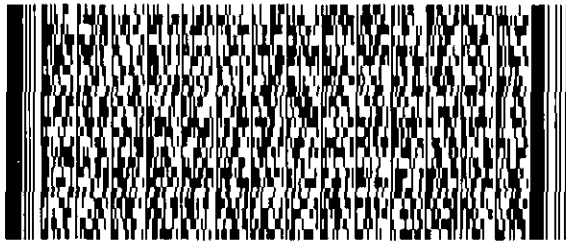
