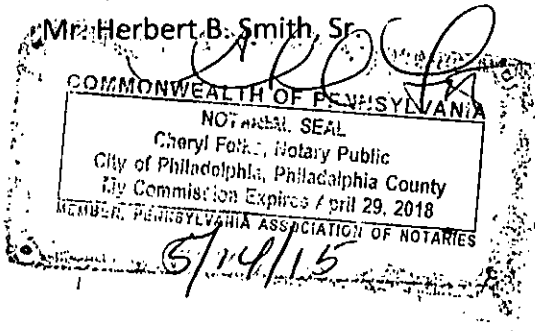

I tried filing the 13 page application, but it was rejected three (3) times and I was told by Mr. Brown to send this type of letter. I ask that you please accept it.

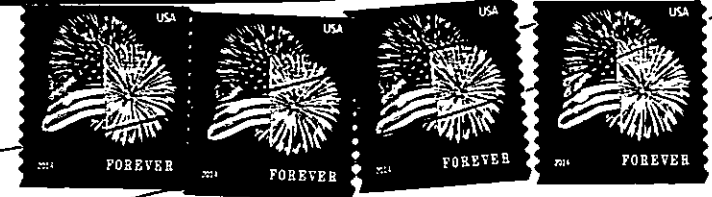

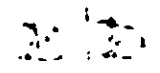

My father organized our Company in 1925 and he join PUC in 1939 We still have the Paper Work.

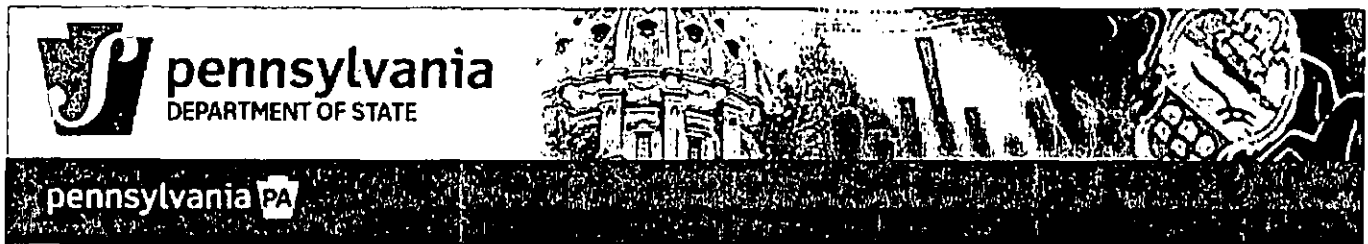
I am a Korean War Veteran<sup>82</sup> and I would want my son to be able to continue operating the business after my departure.

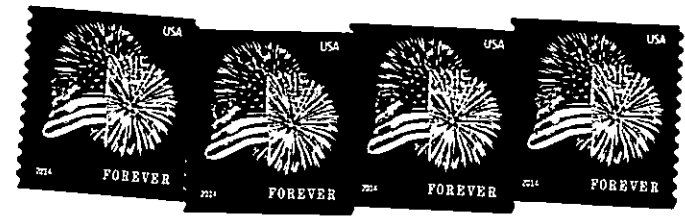

On March 10, 2015, the Commission received your Application of Transfer and Exercise of Common Carrier or Contract Carrier for Herbert B Smith Jr. Upon initial review, the Application had been determined to be deficient for various items. We have received some of these items. However, we are still missing the following Items:

- On Page 5, Item 14, the signature of Transferee should say Herbert B Smith Jr, not Sr
- Missing Sales Agreement with signatures of both seller and buyer.
- Filing fee must be in form of a certified check, money order (not greater than 6 months aged) or check issued by attorney **through his law firm** (not greater than ninety days aged). Personal checks are not accepted. We are returning Check # 14271.

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within 20 days of the date of this letter will result in the Application being returned unfiled.

Upon initial review, the Application has been determined to be deficient for the following reasons:

- The name of Transferee-Buyer on page 2 should say Herbert B Smith Jr, not Sr
- On Page 5, Item 14, the signature of Transferee should say Herbert B Smith Jr, not Sr
- Missing Sales Agreement with signatures of both seller and buyer.
- On page 6, for the Verification, there must also be a **signature** along with printed name of Transferor and Transferee.
- Financial information must be less than 6 months old-there is no indication of this on your financial statement
- Filing fee must be in the form of a certified check, money order or check from your attorney, personal checks are not accepted. We are returning Check # 14271.

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within 20 days of the date of this letter will result in the Application being returned unfiled.
