**JOINT PETITION FOR APPROVAL OF

BETWEEN DEPOSIT TELEPHONE COMPANY, INC.,
MAHANAY AND MAHANTANGO TELEPHONE COMPANY,
SUGAR VALLEY TELEPHONE COMPANY
AND T-MOBILE USA, INC.**

Deposit Telephone Company ("Deposit"), Mahanoy and Mahantango Telephone Company ("Mahanoy"), Sugar Valley Telephone Company ("Sugar Valley") and T-Mobile USA, Inc. ("T-Mobile") hereby request that the Commission review and approve the attached Agreement pursuant to Section 252(a)(1) and 252(e) of the Telecommunications Act of 1996, 47 U.S.C. §§ 252(a)(1) and 252(e) (the "Act"). In support of their request, the parties state as follows:

1. The Agreement was arrived at through good faith negotiations between the parties as contemplated by Section 252(a) of the Act and provides for interconnection as addressed in Section 251 of the Act.

2. Pursuant to Section 252(e)(2), the Commission may only reject a negotiated Agreement if it finds that (1) the Agreement discriminates against another carrier or (2) implementation of the Agreement would not be consistent with the public interest, convenience and necessity.

3. Deposit, Mahanoy and Sugar Valley will make the Agreement available to any other similarly situated telecommunications carrier operating within their respective territories. Other carriers are also free to negotiate their own terms and conditions pursuant to the applicable provisions of the Act. For this reason, the Agreement is not discriminatory.


4. In addition, implementation of the Agreement is consistent with the public interest because it will promote competition and enhance T-Mobile's ability to provide Pennsylvania telecommunications users with commercial mobile radio services.

5. In accordance with Section 252(e)(4) of the Act, the Agreement will be deemed approved if the Commission does not act to approve or rejects the Agreement within 90 days from the date of this submission.

6. Copies of the Agreement are available for public inspection in Deposit, Mahanoy, Sugar Valley and T-Mobile's public offices.

WHEREFORE, Deposit, Mahanoy, Sugar Valley and T-Mobile respectfully request that the Commission approve the attached Agreement under Section 252(e) of the Act as expeditiously as possible.




