

NOW COMES, Hickory Telephone Company ("Telephone Company") and respectfully seeks Pennsylvania Public Utility Commission ("Commission") approval of the attached Interconnection Agreement between Telephone Company and Cingular Wireless, LLP ("Cingular") ("Agreement") under the Telecommunications Act of 1996 ("TCA-96") as interpreted by the Federal Communications Commission ("FCC") in its Order in <u>Developing a Unified Intercarrier Compensation Regime</u>, T-Mobile et al., Petition for Declaratory Ruling Regarding Incumbent LEC Wireless Termination Tariffs, CC Docket No. 01-92, Declaratory Ruling and Report and Order, released February 24, 2005 ("T-Mobile decision"), and pursuant to this Commission's Order entered June 3, 1996, In Re: Implementation of the Telecommunications Act of 1996, Docket No. M-00960799. The Agreement facilitates the provision of service between customers of Telephone Company and Cingular. Telephone Company therefore respectfully requests that the Commission approve the said Agreement. In support of this request, Telephone Company represents as follows:

I. THE PARTIES

- 1. Telephone Company is a rural incumbent local exchange carrier providing local exchange telecommunications services in Pennsylvania.
- 2. Cingular provides wireless services in Telephone Company's local service territory.

II. THE AGREEMENT

- 3. Telephone Company and Cingular have entered into this Agreement pursuant to Section 252 of TCA-96, 47 U.S.C. §252, and the FCC's <u>T-Mobile</u> decision.
- 4. The Agreement sets forth the terms, conditions and prices under which Telephone Company and Cingular will offer and provide network interconnection, reciprocal call transport and termination and other services to each other. The Agreement is an integrated package that reflects a balancing of interests critical to the parties.

III. COMPLIANCE WITH TCA-96

- 5. The Agreement satisfies the requirements for Commission approval pursuant to Section 252(e)(2)(A) of TCA-96, 47 U.S.C. §252(e)(2)(A), which provides as follows:
 - (2) GROUNDS FOR REJECTION.--The State commission may only reject--
 - "(A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that --
 - "(i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or

- "(ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity[.]
- 6. The Agreement does not discriminate against any telecommunications carrier. Other carriers are not bound by the Agreement and remain free to negotiate independently with Telephone Company pursuant to Section 252 of TCA-96.
- 7. The Agreement is consistent with the public interest, convenience and necessity consistent with Section 252(e)(2)(A)(ii), 47 U.S.C. §252(e)(2)(A)(ii). The Agreement permits Telephone Company and Cingular to interconnect their networks and provide reciprocal transport and termination, benefitting end user customers of both carriers.

IV. APPROVAL OF THE AGREEMENT

8. Under Section 252(e)(4) of TCA-96, 47 U.S.C. §252(e)(4), the Commission has ninety (90) days to approve or reject the Agreement. Telephone Company requests that the Commission approve the Agreement without revision as quickly as possible, consistent with the public interest.

WHEREFORE, Hickory Telephone Company respectfully requests that the Commission approve this Petition and the attached Interconnection Agreement pursuant to the Telecommunications Act of 1996.


