I have received a dismissal notice from your office stating that my Truck authority has been revoked due to the failure of my insurance company/agent to file evidence of cargo liability insurance (Form H) with this Commission. I disagree with this determination and am requesting your Reconsideration due to this reason:

1. My agent (TBS) has filed this electronically both within the 60 days required by this Commission as well as again on 06/11/2015 and I have also included this filing in the petition for reconsideration. This was initially filed electronically. The only reasoning I can gather for you not receiving it is a technical issue which none of us have any control over.

I, Jennifer Kowalski, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief and that I expect to be able to provide the same at a hearing held in this matter. Understand that the statements herein are made subject to the penalties of 18 Pa.C.S. § 4904 (relating to unsworn falsification to authorities).

Simple Transport LLC is not now engaged in intrastate transportation of property or passengers for compensation in this Commonwealth except as s authorized by the Pennsylvania Public Utility Commission certificate or permit, and will not engage in the transportation for which approval is herein sought, unless and until the transportation is authorized by your Honorable Commission.
