PETITION TO REOPEN AND FOR RECONSIDERATION AND TO AMEND
APPLICATION TO REFLECT RECENT RULE CHANGE

The within Petition to Reopen and for Reconsideration pursuant to 52 Pa. Code § 5.44(a) is filed, on behalf of Applicant 610 Hauling LLC t/a College Hunks Hauling Junk by and through its attorney, Lewis P. Hannah Esquire, respectfully requests the following :

1. On November 5, 2012, Applicant filed an application for approval for Motor common carrier or Motor Contract carrier of Household Goods in Use.
2. Protests to said Application were filed by Clemmer Moving and Storage, Inc., Hughes Relocation Services, Inc., Fisher-Hughes of Allentown, Inc., Frick Transfer Inc., Gloss Moving and Storage Inc. dba Obrien's Moving and Storage, Keller Moving and Storage Inc. Reads Van Service Inc. and Shelley Moving and Storage on May 24, 2013.
3. On September 13, 2013. The undersigned entered his appearance as counsel of record for Applicant.
4. On October 15, 2013 a hearing was held before Administrative Law Judge Eranda Vero. The Protests were withdrawn as the Applicant and the Protesters agreed upon a revised Restrictive Amendment.
5. Judge Vero rendered her decision on April 3, 2014, a copy of which is attached hereto as Exhibit A .

6. On or about June 2, 2014, Counsel for Applicant was advised that a letter dated May 20, 2014 was forwarded exclusively to Applicant. Said letter, a copy of which is attached hereto as Exhibit B ,established a deadline of May 30, 2014 for the submission of additional documents for review.
7. Upon receiving a copy of the letter dated May 20, 2014, a request for an extension of the due date for additional information was granted extending said date from May 30, 2014 to June 16, 2014.
8. Under cover of letter dated June 12, 2014, in response to the letter dated May 20, 2014, documents were submitted to Josh Kwiatkowski, a copy of the submission is attached hereto as Exhibit C .
9. Thereafter, by letter dated July 21, 2014, inquiry as to the status of Mr. Kwiatkowski's review of the June 12, 2014 submission. A copy of which is attached hereto as Exhibit D
10. On August 5, 2014, Counsel for the Applicant spoke with Mr. Kwiatkowski who advised that he had not received any correspondence or had any contact with Counsel's office. Counsel for Applicant explained to Mr. Kwiatkowski that a package dated June 12, 2014 had been sent to him. Mr. Kwiatkowski directed Counsel to the Office of the Secretary specifically to a "Mr. Brown" to determine if any documents were being held by the Secretary. Mr. Brown explained that since the package was sent to the "P.O. Box" and not to the physical address, the documents may have been lost.
11. On August 5, 2014, at the direction of Mr. Brown, I forwarded the package of documents initially submitted on June 12, 2014 to his attention by way of overnight mail. A copy of the cover letter and mailing receipt are attached hereto as Exhibit E .

12. Upon not receiving a response from either Mr. Brown or Mr. Kwiatkowski a copy of the submission dated June 12, 2014 was forwarded to the attention of each of the Commissioners under cover of letter dated August 15, 2014 a copy of which is attached hereto as Exhibit F.
13. On August 21, 2014 the Commission denied Applicant's application for failure to respond to the request for additional information set forth in the letter dated May 20, 2014. A copy of the decision is attached hereto as Exhibit G.
14. On September 5, 2014 the Applicant filed a Petition for Reconsideration which was granted on November 13, 2014.
15. On November 20, 2014, Applicant submitted additional information that was previously requested a copy of which is attached hereto as Exhibit H
16. Upon review by the Bureau of Technical Utility, it was wrongfully determined that the Applicant had engaged in the unauthorized transportation of Household Goods in Use.
17. The decision states that "unacceptable statements in support of the Application and worse, a log demonstrating 399 moves which occurred without authority". The log made reference to and attached as Exhibit I is a list of clients which the applicant has provided junk removal services for ie. College Hunks Hauling Junk not household goods. See Applicant's application answer to question three attached hereto as Exhibit J. The leap by the Commission that this is a list of individuals which demonstrates 399 moves is unsupported by any evidence and totally unfounded in fact.
18. Additionally, contact has been made with the persons that signed statements supporting the Application. No one contacted acknowledged receiving a telephone call from William Kilrain of the Commission's Philadelphia office.

19. The Applicant respectfully requests that its application be reopened for

reconsideration to


a. Allow the review and clarification of the wrongfully reached conclusions set forth in the Secretarial Letter dated May 8, 2015 a copy of which is attached as Exhibit K and

b. To amend its application to reflect the recent rule changes eliminating the requirement that applicants will serve a useful public service and establishing state wide authority to operate.

ORDER REASSIGNING APPLICATION

On November 5, 2012, 610 Hauling, LLC, t/a College Hunks Hauling Junk (610 Hauling or Applicant) filed an application with the Pennsylvania Public Utility Commission (Commission) for the right to begin to transport, as a common carrier, by motor vehicle, household goods in use, between points in the Counties of Chester, Delaware, Montgomery, Philadelphia and Bucks, to points in Pennsylvania. The Commission caused notice of this application to be published in the May 4, 2013 *Pennsylvania Bulletin* at 43 Pa.B. 2531, specifying a deadline of May 20, 2013, for filing protests.

On May 24, 2013, Adam Meyer, Inc., Clemmer Moving & Storage, Inc., Hughes Relocation Services, Inc., Fischer-Hughes of Allentown, Inc., Frick Transfer, Inc., Glose Moving & Storage Inc., Glose Moving & Storage Inc. d/b/a O'Brien's Moving & Storage, Inc., Keller Moving & Storage, Inc., Reads Van Service, Inc., and Shelly Moving & Storage, Inc., (Joint Protestants) filed a Joint Protests to the Application.

By hearing notice dated August 16, 2013, the Commission scheduled a hearing for this matter on Tuesday, October 15, 2013, at 10:00 a.m., and assigned the case to me. I issued a Prehearing Order on August 23, 2013, addressing, *inter alia*, requests for continuance, subpoena procedures, attorney representation, discovery and the Commission's policy encouraging settlements. The language of the Prehearing Order also reminded the Applicant that the Commission's rules require limited liability companies to be represented by counsel.

On or about September 9, 2013, Lewis P. Hannah, Esq. entered his appearance in this matter on behalf of the Applicant.

By letter dated October 9, 2013, counsel for the Applicant, Mr. Hannah, requested a 30-day continuance of the scheduled hearing for the parties to work on resolving some or all of the issues in this matter. In his letter, Mr. Hannah indicated that counsel for the Joint Protestants had consented to the Applicant's request for the continuance of the hearing.

The Applicant's request for a 30-day continuance of the scheduled hearing was granted. By Hearing Cancellation/Reschedule Notice dated October 22, 2013, the hearing was rescheduled for Monday, January 6, 2014, at 10:00 a.m.

By letter dated January 3, 2014, counsel for the Applicant, Mr. Hannah, requested a second continuance of the scheduled hearing. In his letter Mr. Hannah stated: "We are in the process of seeking to present to the Protestants a modified application that may be acceptable to them." In his letter, Mr. Hannah indicated that counsel for the Joint Protestants had consented to the Applicant's second request for the continuance of the hearing.

The Applicant's request for a second continuance of the scheduled hearing was granted. By Hearing Cancellation/Reschedule Notice dated January 23, 2014, the hearing was rescheduled for Tuesday, February 11, 2014, at 10:00 a.m.

The initial hearing convened as scheduled on February 11, 2014. Lewis P. Hannah, Esq. represented the Applicant and William H.R. Casey, Esq. represented the Joint Protestants. The hearing resulted in a transcript of 15 pages.

At the start of the hearing, Mr. Hannah submitted a "Pre-hearing Memorandum" and made an oral Motion for the Dismissal of the Joint Protests as untimely (Motion). Tr. 7.

In response to the Applicant's Motion for Dismissal of the Joint Protests, Mr. Casey submitted a Petition for Approval of Filing the Joint Protests *Nunc Pro Tunc* (Petition). Tr. 8.

The presiding officer recessed the hearing in order to review the Applicant's Motion and the Joint Protestants' Petition and reach a decision on both of them.

While the hearing was still in recess, the parties informed the presiding officer that they had agreed on a restrictive amendment which resolved all the issues in this matter.

Once the hearing was reconvened, counsel for the Joint Protestants entered the terms of the restrictive amendment into the record in this matter. Tr. 13. The Restrictive Amendment agreed on by the parties, states that the Applicant amends its Application to seek the following authority:

[To begin to transport, as a common carrier] household goods in use from points in Counties of Chester and Philadelphia to points in Pennsylvania.

Tr. 13. Counsel for the Joint Protestants also stated that "[U]pon the Commission's approval of the application, the [Joint] Protestants will withdraw their Protest and we would like to remain a part of the application until it's concluded." Tr. 13. Counsel for the Applicant withdrew its Motion for the Dismissal of the Joint Protests. Tr. 13-14.

On February 28, 2014, I issued an Order instructing the Applicant to comply with the Commission's Rules of Practice and Procedure at 52 Pa. Code § 5.235 and submit a written copy of the agreed upon restrictive amendment.

On or about March 25, 2014, the Applicant submitted a written copy of the Restrictive Amendment, signed by counsel for the Applicant and the Joint Protestants.

In order to find that a restrictive amendment is in the public interest, the Commission must find that adopting the restrictive amendment would serve to protect a legitimate public purpose. The public need for the proposed service is the relevant factor in determining the public interest, while protection of private economic interests and competitive positions is not. *Crown America Corp. v. Pa. Pub. Util. Comm'n*, 463 A.2d 1257 (Pa. Cmwlth. 1983); *Glenside Suburban Radio Cab, Inc. v. Pa. Pub. Util. Comm'n*, 411 A.2d 874 (Pa. Cmwlth. 1980); *Highway Express Lines, Inc. v. Pa. Pub. Util. Comm'n*, 169 A.2d 798 (Pa. Super. 1961).

The Commission has rejected restrictive amendments where the amendment proposed to limit the type, make or color of vehicle used to provide service as contrary to the public interest. *Application of Sean McDonough t/d/b/a Northstar Executive Transportation*, Docket No. A-00118757 (Order entered December 4, 2002); *Application of Yvonne Victoria Kulp t/d/b/a YV Kulp Transportation*, Docket No. A-00119913 (Order entered April 8, 2004); *Application of Gene Leman t/a Bangor Cab*, Docket Nos. A-6410442 and A-2008-2061044 (Order entered September 4, 2009). In these cases, the Commission rejected the restrictive amendments because they would limit the nature and quality of the equipment to be used by the applicant to provide the service, would unduly and unreasonably fragment the operating authority of the applicant and would create enforcement difficulties for the Commission by establishing operating rights that are unrelated to the Commission's statutory and regulatory responsibilities. The Restrictive Amendment submitted by the Applicant and the Joint Protestants does not limit the type, make or color of vehicle used to provide service. In addition, the Restrictive Amendment does not unduly and unreasonably fragment the operating authority of the Applicant, nor does it establish operating rights that are unrelated to the Commission's statutory and regulatory responsibilities.

The Commission's regulation at 52 Pa. Code § 3.381(c)(1)(iii) provides that if all protests to an application for passenger authority are withdrawn at or prior to the hearing, the Commission may consider the application without holding an oral hearing, based on verified statements filed by the applicant. Since no protests other than those filed by the Joint Protestants were filed to 610 Hauling, LLC, t/a College Hunks Hauling Junk Application, this matter shall be referred to the Commission's Bureau of Technical Utility Services for further review under the procedure set forth at 52 Pa. Code § 3.381(c)(1)(iii).

This matter comes before the Commission on an application filed November 5, 2012. The application was published in the Pennsylvania Bulletin of May 4, 2013, with protests to be filed on or before May 20, 2013. On May 21, 2014, a joint protest was filed by Adam Meyer, Inc., Clemmer Moving & Storage, Inc., Fisher-Hughes of Allentown, Inc., Hughes Relocation Services, Inc., Frick Transfer, Inc., Glose Moving & Storage, Inc., Glose Moving & Storage, Inc., d/b/a O' Brien's Moving & Storage, Inc., Keller Moving & Storage, Inc., Reads Van Service, Inc., and Shelly Moving & Storage, Inc. Subsequently, the application was reassigned to the Bureau of Administrative Law judge for mediation. On March 24, 2014, an executed Restrictive Amendment was submitted which resolved all protests, and on April 3, 2014, the application was reassigned back to the Bureau of Technical utility Services for review under modified procedure.

On May 20, 2014, the applicant was requested to furnish additional information to supplement its previously filed verified statements. This information was due no later than June 3, 2014. This request was inadvertently issued directly to the applicant and not its counsel; on June 2, 2014, the applicant's attorney contacted the assigned Compliance Specialist to point out the mailing oversight and to request a filing extension. 

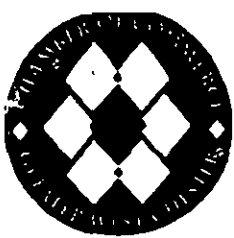

1. A 1500 sq ft warehouse space located in West Chester, PA. The building has two loading docks and ample parking for both company and employee vehicles. In addition the lot is gated and is locked at the close of business each day. Office equipment consists of wireless internet, computers, printers/copier/scanner and a paper shredder. Also a file room that is able to be locked is used to house PUC and normal business records. Customer requests for service will come through either our online booking website or received through a central call center located in Tampa, FL. Jobs are entered into a our scheduling software that can be accessed from mobile and computer devices. Jobs entered into this system are then contacted by a local employee to discuss the details of the job and to ultimately book if the customer chooses to do so. All moving trucks will have access to a cell phone and each truck has GPS tracking. This allows us to see where trucks are at all times and to monitor that they are being driven responsibly. Jobs are booked between the hours of 8am-6pm Monday-Saturday.

6a. All drivers will have previous driving experience. Experience in the moving industry is preferred. All potential employees first fill out an online application to see if they might be a possible fit for this position. We ask questions about how they work in a team, how they handle a difficult situation, and how there values compare to the core values of the company. All potential employees will be then contacting for a phone interview and then 2 face to face interviews with management. We strive for the highest level of customer service and monitor it very closely. Each job gets a survey upon completion that monitors how the crew did. So we will be looking for employees that meet that high standard and can "WOW" our clients.

b. A background (criminal) will be performed for each employee. We use ADP a background check service for all potential employees. We have a checklist of items that must be passed prior to an employee starting and one of those items is a background check must be run and the results received and reviewed prior to an employee starting.

c. The training program will consist of classroom and on the job training. For the classroom portion we use an online training portal that consists of a variety of lessons that focus on company history, standards, how to properly lift, how to properly handle items, how to safely handle the vehicle etc. Each lesson consists of videos, and documents that they must watch and read. At the completion of each lesson there is a quiz that must be passed before they can continue. Failure to pass the class results in the employee having to redo training. Upon completion they receive a certificate stating they passed. Management can also go in and review all there results. In addition each new employee goes out and observes an experienced crew a minimum of 4 times before they get scheduled to their own crew. We also do sample moves in our warehouse on how to properly wrap and protect the items being moved.

d. Employees license will be checked prior to starting. After that it will be randomly checked throughout the year. A minimum of 3 times each year. A calendar is maintained that management uses that alerts them on when to run the licenses.

e. The calendar mentioned above will also be used to ensure background checks are ran every two years. We also use this calendar for when to conduct employee reviews as well.

f. There is a ZERO tolerance policy for drug and alcohol use. Employees can be randomly checked.

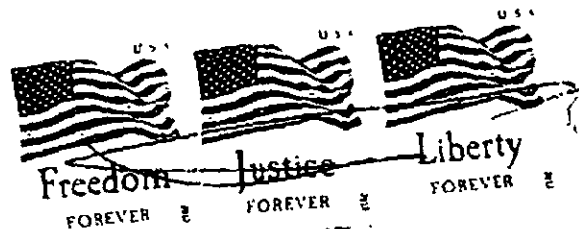


The purpose of this Letter is to advise you that your application, Docket No. A-2012-2388651, has been **DENIED** by the Pennsylvania Public Utility Commission (Commission). The Commission has determined that a Certificate of Public Convenience **WILL NOT BE GRANTED** for the following reason(s):

Failure to establish need for the requested service/propensity to operate illegally.

On August 21, 2014, the applicant was denied due to failure to timely respond to a Commission data request for clarification of its verified statements and for verified statements in support of the application. On September 5, 2014, the applicant petitioned the Office of Special Assistants for reconsideration and submitted multiple unacceptable statements in support of the application, and worse, a log demonstrating 399 moves which occurred without authority. Notwithstanding the evidence of unauthorized transportation of Household Goods in Use, the petition was granted on November 13, 2014. Subsequently, on November 20, 2014, the applicant submitted the previously requested information. Upon review by the Bureau of Technical Utility Services, it was determined that the majority of the applicant's verified statements of support failed to comply with the requirements set forth in 52 Pa. Code § 3.382, and or the Commission's decision in the Application of Blue Bird Coach Lines, Inc., (A-00088807, F.2, Am-K) 72 Pa. P.U.C. 262 (1990). On April 20, 2015, Manager William Kilrain, of the Commission's Philadelphia District Office attempted to contact the 11 persons that allegedly signed statements supporting the application, but was unable to make contact with any of them.

For this reason(s), your application is **DENIED** and **DISMISSED**.

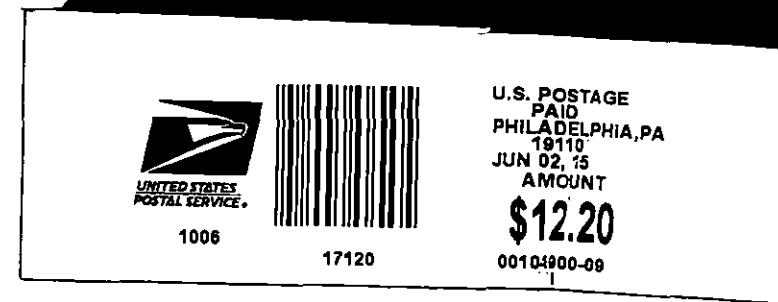
