I am writing this letter in response to a complaint filed against my company, Nasser Limousine LLC, DOCKET NO. C-2015-2485631. The complaint was that Nasser Limousine had no FORM E on file, however we did have insurance effective May 27<sup>th</sup> 2015 but because of a clerical error with our address the FORM E was not recognized. We maintain two addresses for Nasser Limousine, 137 W. Market St. Scranton PA 18509 and a secondary address at 4751 Birney Avenue Moosic, PA 18507.

I spoke with Public Compliance Chief Robert Bingham on Monday June 15, 2015 and as of our verbal conversation he agreed to recognize our FORM E on file and add our second address of 4751 Birney Avenue Moosic, PA 18507 to your records. At that time Mr. Bingham told me that the complaint was closed and further action was not needed by myself or Nasser Limousine. I asked him to send me an email verification of this to my personal email address johnnasser@aol.com, which he stated he would send by the end of the day by June 15, 2015. I did not receive the email verification that the complaint was closed as Mr. Bingham said he would. I wrote him an email requesting the verification that the complaint was closed on Tuesday June 16, 2015 and again called him via phone on June 16, 2015 and I received no response to either the email or phone call. I once again called Mr. Bingham on June 17, 2015 and again received no response. I then called David W. Loucks and he informed me that the proof of insurance, FORM E is on file but the complaint was still open and I had to answer it and pay a \$500.00 fine. I don't see how this is possible after The Compliance Chief Robert Bingham told me the complaint was closed and I did not need to take further action.

Since my Insurance Company has provided proof of insurance and a FORM E on file (see attachment) I am asking if you can please close this complaint DOCKET NO. C-2015-2485631 and waive the \$500.00 fine which would be a financial hardship on me. If you need to contact me directly my cell phone number is 570-871-1465. Thank you for your prompt attention to this matter. Please note that in the complaint was issued on May 21, 2015 but not post marked until June 3, 2015. Therefore we did not receive it in our office until June 9, 2015. See attachments

As of 05/24/2015, your PUC operating authority is **SUSPENDED** due to your failure to maintain evidence of insurance on file with this Commission. **You may not operate while under suspension.** Operating while under suspension is subject to prosecution, which may result in cancellation of your authority.

**Your insurer** must file appropriate evidence of insurance with the Commission. Appropriate evidence of insurance is a FORM E for bodily injury and property damage liability insurance, a FORM H for cargo liability insurance, or a Surety Bond. These forms must be filed with the PUC by the Insurance Company or Agent, **not by you.** Incomplete forms, incorrect forms and fax transmittals will **NOT** be accepted. The Commission does permit electronic filing of these forms.

If this Commission does not receive acceptable evidence of insurance within ten (10) days of the suspension date, a Complaint will be instituted against you for failure to comply with this Commission's insurance requirements. The Complaint may result in the cancellation of your PUC operating authority.

If your insurer timely files appropriate evidence of insurance, you will receive Notice from the PUC authorizing you to resume operations. **You may not resume operations until you receive this Notice from the Commission.**

**Please notify the Commission if you are no longer in business.**

If you believe that you have received this Notice of Suspension in error or if you have any questions regarding the suspension of your authority, please contact the Motor Carrier Services and Enforcement Division in the Bureau of Investigation and Enforcement at 717-787-1227.
