

Pursuant to 52 Pa. Code § 54.34 and 52 Pa. Code § 62.105 Washington Gas Energy Services, Inc. hereby notifies the Pennsylvania Public Utility Commission ("Commission") that Washington Gas Energy Services, Inc. is changing its corporate name to WGL Energy Services, Inc. ("the Company"), effective January 15, 2015. Enclosed herewith are documents and state corporate filings evidencing the name change. As set forth below, the name change will not alter the information provided by the Company in its Electric Generation Supplier and Natural Gas Supplier license applications and amendments thereto, its filings made to comply with reporting requirements under the Commission regulations, or Company marketing activities authorized by the licenses.

Pursuant to Commission Orders entered July 16, 2010, December 3, 2010 and August 21, 2014 in Docket No. A-2010-2176410 the Company is licensed as a Natural Gas Supplier ("NGS") in the service territories of Columbia Gas of Pennsylvania, Inc., PECO Energy Company, UGI Utilities, Inc., UGI Central Penn Gas Inc., UGI Penn Natural Gas, Inc., Philadelphia Gas Works, National Fuel Gas Distribution Corporation, Peoples Natural Gas Company, LLC, Peoples Natural Gas Company, LLC, Peoples Natural Gas Company, LLC – Equitable Gas Division and is currently serving customers in all of these territories.

Pursuant to Commission Orders entered January 15, 2003 and December 2, 2010 in Docket No. A-110158, the Company is licensed as an Electric Generation Supplier ("EGS")in the service territories of PECO Energy Company, PPL Electric Utilities Corporation, Allegheny Power, Duquesne Light Company, Metropolitan Edison Company, Pennsylvania Electric

Company, and UGI Utilities, Inc. - Electric Division and is currently serving customers in all of these territories.

The name change for the Company is part of a comprehensive rebranding initiative of the family of companies owned by WGL Holdings, Inc. a registered holding company, in which its energy commodity business is being rebranded under the name WGL Energy Services, Inc. Accordingly, the Company has filed an Amendment of its Certificate of Incorporation with the State of Delaware, the state of its incorporation, noting the name change. A copy of the Certificate of Amendment issued to the Company by the Delaware Department of State, Division of Corporations, is attached as Exhibit A. As a licensed competitive energy supplier in Pennsylvania the Company is also qualified to do business in the Commonwealth of Pennsylvania, and the Company has filed an Application for Amended Certificate of Authority with the Pennsylvania Department of State, Bureau of Corporations and Charitable Organizations, a copy of which is attached hereto as Exhibit B.

The name change will have no impact on the Company's operations or the delivery of electricity and natural gas to its customers. WGL Energy Services, Inc. will continue to be responsible for all the obligations that are associated with maintaining its licenses including complying with all supplier obligations under the Natural Gas Choice and Competition Act of 1999, 66 Pa. C.S. §§ 2201 et seq., the Electricity Generation Customer Choice and Competition Act of 1996, as amended, 66 Pa. C.S. §§ 2801 et seq., the Commission's regulations applicable to EGSs and NGSs, and the relevant utility tariffs which are applicable to EGSs and NGSs.
