To Whom It May Concern;

I am writing to express my grave disagreement of this fine. It is completely unfair and unjust. This company has been in the process of closing since our agent and/or insurance company made a fatal error and our policy was cancelled. Due to this cancellation and the fact that the FMCSA's scoring/reporting is entirely geared to aid the larger trucking companies and damage the smaller companies, I could not find a company that would insure me solely because of my score with the FMCSA.

During this process and trying to rectify the situation (which began at the beginning of January 2015) I had spoken with countless persons from my insurance agency; the FMCSA; and the PA PUC. In speaking with ALL of them I had explained our situation in excess, trying to find a legal way to continue to operate since this is our family's only means of income. I was transferred, put on hold for hours and at one point completely redirected to the person I first began speaking with. During all of this NO ONE, (not even the lady from the PA PUC), had informed me that I needed to notify the PA PUC in writing in order to not be fined. They were notified by phone, I had spoken with them on several occasions trying to find a way to get insured and operate, thinking that they may have a resource I had no access to.


The beginning of June 2015, I receive this cancellation notice in the mail – cancelling my PA PUC authority as well as fining me the \$500.00. As I have stated this is completely unfair. None of the actions that had resulted in the closure of this company (which we are still in the process of doing) were of my doing or my fault in any way. I do not think I should have to pay a fine, especially when I had called the division the fine is coming from, trying to get help for what they are fining me for and even then was not made aware of legal actions that needed to be taken to avoid such fines.

I am asking that this fine be reconsidered and/or voided.

Thank you for your time and reconsideration.

I, Matthew McMullen, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief and that I expect to be able to provide the same at a hearing held in this matter. Understand that the statements herein are made subject to the penalties of 18 Pa.C.S. § 4904 (relating to unsworn falsification to authorities).
