
Dear Ms. Chiavetta:

Evergreen Trails, Inc. ("Evergreen") t/a Horizon Coach Lines holds certificate number A-641555 allowing it to provide group or party service within Pennsylvania. The Complaint issued in the above-referenced docket alleges that Evergreen failed to maintain proof of valid insurance on file with the Commission. Evergreen does not contest the allegations in the Complaint. However, Evergreen respectfully requests that the Pennsylvania Public Utility Commission ("Commission") waive the \$500 fine set forth in the Complaint and cancel Evergreen's authority for the reasons explained below.

Evergreen's attempts to attract customers for intrastate transportation in Pennsylvania proved unsuccessful and Evergreen therefore never actually provided intrastate service in Pennsylvania. Evergreen did operate in Pennsylvania as part of interstate operations. It last operated in Pennsylvania on this basis on January 7th, 2015 and shortly thereafter, decided it would not be operating in Pennsylvania for the foreseeable future. Because Evergreen would not be operating in Pennsylvania, it did not renew its insurance policy applicable to its Pennsylvania operations. However, Evergreen was not aware that it was required to request cancellation of its authority and did not raise the matter with its attorneys until receiving the Complaint. Enclosed with this letter is a formal request to cancel Evergreen's authority (certificate number A-641555).

Counsel for Evergreen spoke with Commission staff on July 2, 2015 and was informed that in circumstances similar to those described above, the Commission typically waives the fine. In addition, Commission staff informed counsel for Evergreen that submitting this request for waiver of the fine in lieu of submitting payment would not subject Evergreen to additional penalties should the Commission ultimately determine not to waive the fine.
