Dear Secretary Chiavetta:

Enclosed for filing on behalf of Interstate Energy Company, f/k/a PPL Interstate Company, is an original Supplement No. 2 to Tariff Pipeline - Pa. PUC No. 7 to change the operating name of the Company pursuant to Docket Nos. A-2014-2435752 and A-2014-2435833. Also enclosed is a certified copy of the name change notification filed with the Pennsylvania Department of State. As explained below, there will be no change in the operations, areas served, or scope of services offered as a result of this change.

Interstate Energy Company is a public utility under the Public Utility Code providing transportation of oil and natural gas to electric generating stations pursuant to certificates of public convenience granted by the Pennsylvania Public Utility Commission ("Commission"). Interstate Energy Company currently owns and operates two pipelines that deliver fuel to two generating plants owned and operated by subsidiaries of PPL Energy Supply in Lower Mount Bethel Township, Northampton County, Pennsylvania.

Prior to June 1, 2015, Interstate Energy Company was a wholly owned, indirect subsidiary of PPL Corporation ("PPL Corp."). On April 15, 2015, the Commission entered an Opinion and Order at Docket Nos. A-2014-2435752 and A-2014-2435833 that, among other things, approved a transaction to transfer Interstate Energy Company from control of PPL Corp. to control of

Talen Energy Corporation (“Talen Energy”).<sup>1</sup> On June 1, 2015, PPL Corp. and Talen Energy closed on the transaction. Consequently, as of June 1, 2015, Interstate Energy Company is a wholly owned, indirect subsidiary of Talen Energy.

On June 17, 2015, Interstate Energy Company changed its corporate name from “PPL Interstate Energy Company” to “Interstate Energy Company”. Interstate Energy Company has submitted the required name change notification with the Department of State, which is enclosed. Interstate Energy Company will continue to operate under the existing tax identification for PPL Interstate Energy Company.


Supplement No. 2 to Tariff Pipeline - Pa. PUC No. 7 reflects the corporate name change and updates the physical address and the President of Interstate Energy Company. No other changes to any tariff rates or rules have been made.

Interstate Energy Company will continue to offer the same services previously provided under the name PPL Interstate Energy Company, subject to the requirements and conditions of its Commission-approved tariff. There will be no changes in operations, services offered, customer types served, or areas as a result of the name change.

Based on the foregoing, Interstate Energy Company, f/k/a PPL Interstate Energy Company, respectfully requests that the Commission approve Supplement No. 2 to Tariff Pipeline - Pa. PUC No. 7 to be effective June 17, 2015.
