

We have proposed something that is workable to both Duquesne light and us but since that is not going anywhere we are ready for formal proceeding through our lawyers. In this event, all communications between Duquesne light and it counsel to us will be permanently severed.

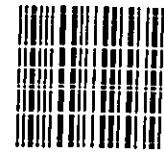
