During the May 4, 2001 conference call the parties, with the exception of PGW, indicated that they did not want to cross-examine Mr. Wheaton, the audit project manager, concerning the Stratified Management and Operations Audit Report ("Audit Report").

Mr. Holland, PGW's counsel, asked whether the other parties would be proposing rate adjustments based on the audit report. At the request of the presiding officer, Mr. Holland prepared and distributed a matrix indicating whether PGW accepted the audit recommendation in whole or in part or whether PGW rejected the recommendation. This was designed to assist the parties in determining PGW's position on each of the 76 recommendations.

Three parties have responded. Counsel for OTS and OCA stated that they did not intend to propose any adjustments that had not been identified as an issue or set forth in the testimony they filed. Counsel for CEPA et al argued that the issues and legal theories have been identified in prehearing memoranda, pre-filed testimony and the discovery disputes. CEPA et al objects to limitations on the use of the audit report.

Since the parties have not identified any additional issues based solely on the audit report, PGW must decide the scope of its cross-examination for Mr. Wheaton.

The presiding officer's goal is to have a complete record so that a fair and just decision can be rendered. Therefore, new issues should not be raised at the briefing stage.
