Your Honor:

On behalf of Duquesne Light Company, I would like to request that the prehearing conference scheduled in this case for next Wednesday, May 17, be postponed until at least the end of this year. FERC is currently holding hearings in its Seams Elimination Charge Adjustment (SECA) proceeding, and an Initial Decision is required from the presiding ALJ on or before August 11, 2006. Additionally, many parties have recently negotiated settlements with other parties, or are in the process of negotiating settlements, including Duquesne, which along with the final FERC Order in the proceeding will ultimately determine the amount of Duquesne's SECA liability and the amount to be borne by Duquesne's POLR customers in this case. Consequently, the resolution of the issues at FERC, expected by the end of this year, will have a direct impact upon this proceeding. I have contacted all the parties to this proceeding, and none of them object to a postponement of the prehearing conference until at least December 1, 2006.
