

Dear Judge Watson:

We are writing to ask for permission to intervene as parties in the two cases (noted above) which have been filed by the Office of Consumer Advocate against our water and wastewater utility, Hidden Valley Utility Services, L.P. We own a second home at 1755 Greenfield Drive, (Hidden Valley) Somerset, Pennsylvania and accordingly we are customers of Hidden Valley Utility Services, L.P. We have owned the house and been customers of the utility since approximately June 2006.

As customers of the utility, we remain concerned about the quality of services and the utility's ability to remain financially viable and able to provide continuous and reliable water and wastewater services. One of us, Bob Kollar, sits on the board of directors of the Hidden Valley Foundation, Inc., (the Foundation) the master homeowners association for the Hidden Valley residential community. Because of Bob's involvement as a director of the Foundation, he has

taken the time to review the financial reports filed by the utility, and his observations form the basis of our concerns. Bob has separately submitted his written direct testimony on this point which we both adopt and ask to be permitted to present at the evidentiary hearing of these cases.

We are not yet aware of any proposals that OCA may be recommending as a final resolution to this matter. However, because of our concerns as stated above, we would request the right to be heard on any final proposed resolution of this matter. It is our understanding that we need to be a party to these proceedings in order to preserve that right.

If your honor requires us to submit any other forms or information in order to justify or formalize this request, we will do so promptly. This letter request, and everything that we have stated here, is submitted and verified as true and correct (or are true and correct to the best of our knowledge, information and belief) and that we expect to be able to prove the same at a hearing held in this matter. We understand that the statements herein are made subject to the penalties of 18 Pa.C.S. Section 4904 (relating to unsworn falsification to authorities).
