Dear Judge Watson:

I am writing to request a change in venue from a telephonic hearing in Pittsburgh in August 2015 to an in person hearing in Philadelphia, PA, at a mutually acceptable time, for the reasons set forth below.

I have alleged in my pleadings that I am disabled under the meanings of the Americans with Disabilities Act (ADA), and have requested reasonable accommodations from PECO under the ADA, and I believe that no one can appreciate my disabilities which are pivotal in my case. In a telephonic communication, but, rather, should see for themselves in person. One of my health care providers has graciously agreed to drive me to Philadelphia and testify in my case if the venue can be changed, since I am unable to drive to the City of Philadelphia myself due to my disabilities.

I am not asking for an opt out of installation of a Smart meter, as Ms. Lee and PECO erroneously conclude.

I am asking for an accommodation under the Americans with Disabilities Act, which I am preparing to argue in person, with the help of my health care provider and several expert witnesses.

Thank you for your understanding and your consideration.


