TO THE HONORABLE, THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

The Archdiocese of Philadelphia ("Archdiocese"), by and through its undersigned counsel, hereby files, pursuant to 52 Pa. Code §§ 5.71 – 5.74, the within Petition to Intervene in the above-captioned proceeding, and, in support thereof, avers as follows:

The Parties

1. The Archdiocese is the governing and organizational body for the more than 1,200,000 Roman Catholics residing in the five-county Philadelphia metropolitan area (Bucks, Chester, Delaware, Montgomery and Philadelphia).

2. The Archdiocese in Philadelphia County includes more than 100 parishes (consisting of churches, administrative facilities, rectories, convents, and other structures), more than 70 parish schools, 10 high schools, specialized schools and social service centers; health care and elder care facilities, and office buildings.

3. The Roman Catholic population in the City of Philadelphia is in excess of 300,000, and the Archdiocese's schools, social services, health care services and facilities serve both the Catholic and non-Catholic population.

4. Respondent Philadelphia Gas Works ("PGW") provides natural gas to Archdiocesan facilities as fuel for heat, hot water and/or other appliances and operations.

The Proceedings

5. PGW submitted its Tariff Supplement No. 16 ("Tariff") filing to the Commission on or about December 22, 2006.

6. PGW seeks rate increases for the type(s) of services and rate classes the Archdiocese uses in its facilities.

7. PGW filed a petition (the "Petition") seeking to increase its delivery charges for gas provided to the Archdiocese.

The Archdiocese's Interest in the Proceedings

8. PGW currently bills the Archdiocese under one of two (2) tariff rates at issue in the current 1307(I) filing: Rates GS-Commercial and GS-Residential.

9. The Archdiocese's total natural gas expenditures in the above rate classes for the facilities described above during Fiscal year 2006 were approximately \$1,000,000.

10. As a ratepayer and large-scale consumer of natural gas supplied by PGW, the Archdiocese is interested in, and affected by, both the proposed base rate increases and the existing and proposed revised terms of service under PGW's tariff.

11. The increased rate will materially and negatively affect the Archdiocese's budget on several levels, including, *inter alia*:

- (a) The increased rates, applied across multiple rate classes and throughout the Archdiocese's facilities, will add significantly to the cost of a major component of the Archdiocese's operating expenses for its facilities.
- (b) The increased expenditures, for which no provisions have been made in the

current fiscal year's budget, place the Archdiocese in the untenable position of having to cut consumption, to the detriment of the health and safety of its parishioners, students, social and health care service clients, and staff, or to allocate funds at the expense of critical services and programs.

12. As a ratepayer, the Archdiocese will be affected by and bound by any determination the Commission makes with respect to the Petition for the following reasons:

- (a) The Archdiocese has a pre-existing and limited budget for utility expenses for its facilities;
- (b) The Archdiocese is a non-profit organization which relies largely upon private donations for its operating funds;
- (c) The Archdiocese purchases gas on various rate schedules, all of which may be adversely affected by increases in the respective rates.
- (d) Imposing a higher rate on the Archdiocese would tax already scarce resources even further, while effectively rewarding PGW for inefficiencies in management and cost control practices.
- (e) This rate increase should not apply to Archdiocesan related properties as the Archdiocese is a reliable ratepayer and should not be punished for the delinquent payments of other customers.

13. The public, particularly that segment of the public that visits Archdiocesan facilities, attends its schools or receives health or social services from Archdiocesan related organizations, also has an interest in keeping energy costs for the Archdiocesan related properties at a manageable level.

14. If permitted to intervene, the Archdiocese will take the position that the increases PGW seeks are excessive and unmerited as to the Archdiocese.

WHEREFORE, the Archdiocese of Philadelphia respectfully requests that the Commission grant its Petition to Intervene and permit the Archdiocese to participate in the consolidated proceedings as if it were a full party to the action.

**PHILADELPHIA GAS WORK'S OBJECTION TO OFFICE OF THE PHILADELPHIA
HOUSING AUTHORITY'S INTERROGATORIES I-1, I-7, I-34 AND I-35**

The Philadelphia Housing Authority ("PHA") served the following interrogatories to Philadelphia Gas Works ("PGW"):

PHA-I-1 Please provide all documents explaining the origin and continuation of the current tariff structure involving gas service to PHA and its residents, including, but not limited to billings or declination of use of the Residential and Commercial GS rate, the PHA rate and the Municipal MS Rate, including, but not limited to:

- (a.) a list of all customers that receive the Municipal MS Rate and the basis of the determination of eligibility for that rate class
- (b.) a list of all customers that are billed at the PHA rate and the basis of the determination of eligibility for that rate class
- (c.) a list of all customers receiving the Municipal MS Rate at locations in which the any portion of billing location use is residential.

PHA-I-7 Please provide the past three years of account histories (billing and payment information) with regard to all customers at the addresses listed at locations in the attached Exhibit "A". Include in the response all descriptions of types and amounts of all credits or rebates provided by PGW or others for each of those locations.

PHA I-34 Please describe in detail the history of PGW's proposed sale of the Richmond LNG plant to Hess Corporation ("Hess"), including, but not limited to:

- (a.) The date and manner in which PGW began communications with Hess with respect to the Richmond LNG Plant
- (b.) The proposed financial terms for the sale
- (c.) Improvements/expansions of the Richmond LNG Plant being planned or implemented at the time PGW began communications with Hess regarding the sale
- (d.) Improvements/expansions of the Richmond LNG Plant planned or implemented during the course of communications with Hess
- (e.) PGW's decision-making process in its election not to complete the sale
- (f.) All persons involved in the negotiations for PGW and Hess and all PGW personnel involved in the consideration of the sale

(g.) Please produce all documents referring or relating to the potential sale of the Richmond LNG Plant to Hess.

PHA I-35 With respect to the matters inquired into in PHA I-32 above, please state whether PGW communicated with any third party other than Hess Corporation, and, if so, for each such third party, please provide the information requested in PHA I-31 a-g for such third party.

In PHA I-1, parts (a) and (c), PHA is seeking customer information (i.e. MS Rate customer information) that is confidential pursuant both to both PaPUC regulations and PGW Personnel Policies and Procedures. Specifically, the PaPUC Code prohibits the release of private customer information to a third party. 52 Pa.Code §62.78. Additionally, PGW Personnel Policies and Procedures prohibit disclosure of customer account records in order to protect the Company's customers.¹ As for part (b), PGW has discussed an alternative response to part (b) with PHA and PGW has agreed to confirm (as the sole response to part (b)) that PGW does not bill the PHA "Rate 8" to any customer other than the Philadelphia Housing Authority.

In PHA-I-7, PHA has requested all billing and payment information during a three year period for over 4,000 customers (PHA tenants who are directly billed) listed in the Exhibit that is referenced in PHA I-7. PGW is currently working cooperatively on a project with PHA in order to provide data similar to the data requested in PHA I-7.

¹ PGW HUMAN RESOURCES DEPARTMENT PERSONNEL POLICY AND PROCEDURES – UNAUTHORIZED DISCLOSURE OF COMPANY INFORMATION – Number #003-15 states in part:

I. Policy

The policy of the Philadelphia Gas Works is to prohibit the unauthorized access, modification, misuse, disclosure, or destruction of confidential company records and corporate information. The Company will take measures to protect all information to assure security, reliability, integrity, and authorized availability of information.


II. Purpose

The purpose of this policy is to protect the Company, the employees, and the customers of the Philadelphia Gas Works from the willful unauthorized access, disclosure or dissemination of the information which includes, but is not limited to, personnel data, financial statements, customer account records, operational procedures, legal matters, descriptions of systems and applications, and other information, the disclosure of which may have an adverse effect upon PGW, its customers, and/or employees.

Generating this data is both costly and time consuming and the Company does not have the resources to provide this data in the instant case's discovery time frame. The Company will continue to work cooperatively with PHA in order to provide this data but providing this data within the discovery time frame is beyond the standard of "overly burdensome" in that the Company doesn't have the capability of producing the requested data within the requested time frame.

PHA 34 and 35 request data related to "PGW's proposed sale of the Richmond LNG plant to Hess Corporation" or a proposed sale to any other third party. As a threshold matter, a "sale" was never proposed, rather, it was a development agreement. Nonetheless, the issue is irrelevant to PGW's rate increase request because negotiations with Hess for the development of the Richmond site are defunct and PGW is not negotiating with any third party in order to develop the Richmond site into an LNG shipping facility. Additionally, PGW has confirmed the aforementioned negotiation status in its response to Office of the Trial Staff's Data Request RB-5. Furthermore, the test year does not contain any funding whatsoever for the aforementioned negotiations and the development of the Richmond site and the Company has stated so in its response to Office of the Trial Staff's Data Request RE-55.






