The School District of Philadelphia, Intervenor ("the School District") submits the following Pre-Hearing Memorandum in response to the pre-hearing conference notice and order issued by the Administrative Law Judges ("ALJs") and pursuant to Section 333 of the Pennsylvania Public Utility Code, 66 Pa.C.S. §333:

I. Background

A. The Parties

The School District, an agency and instrumentality of the Commonwealth, governed by a five-member School Reform Commission, operates the public school system in the City of Philadelphia, and is the seventh-largest public education school district in the United States. The School District provides general, special and vocational education at elementary and secondary levels, as well as related support programs and services. The School District also provides preschool services where the community's needs warrant. The School District owns and/or operates some 273 school buildings and a total of 327 total facilities, including, by way of example, field houses, warehouses, garages, administration buildings, and a working farm. Approximately 280 School District facilities use natural gas as fuel for heat, hot water and/or other appliances and operations.

Philadelphia Gas Works ("PGW") provides natural gas supply and delivery services within the City of Philadelphia to residential and institutional customers, including the School District.

B. The School District's Current Dealings with PGW

The School District currently purchases natural gas from PGW in three (3) rate classes at issue in PGW's subject tariff filing: Rate BPS-L, Rate BPS-S, and Rate MS. The School District's natural gas consumption during Fiscal Year 2006 was 10,010,269 ccf, at a cost to the School District of \$16,332, 882.

Although many of the School District's facilities are individually metered, the School District processes payments for all its gas-powered facilities from its central offices.

C. Procedural History

On December 22, 2006, Philadelphia Gas Works ("PGW") filed Supplement Number 16 to its tariff to become effective February 20, 2007. The tariff proposes changes in rates calculated to produce over \$107,000,000 in annual revenues.

The Commission entered an order on February 8, 2007 suspending the filing pursuant to 66 Pa. C.S. § 1308, until September 28, 2007. The commission order also directed an investigation to determine the lawfulness, justice and reasonableness of a proposed tariff, and assigned the matter to Administrative Law Judges Cynthia Williams Fordham and Angela T. Jones in Philadelphia.

The School District's Petition to Intervene, filed on February 16, 2007, was granted without objection during the initial Pre-Hearing Conference held on February 23, 2007, by Administrative Law Judge Fordham. The School District is permitted to proceed as a full party to the proceedings. By order dated March 2, 2007 Administrative Law Judges Fordham

and Jones required the School District and other intervenors to submit Pre-Hearing Memoranda not later than March 8, 2007.

II. Issues

The following list is a preliminary list of potential issues that the School District may seek to address in the case. The School District reserves the right to address other issues as it deems appropriate as those issues arise. Prehearing memos from other parties have indicated numerous areas common to many or all parties; thus, the School District will use its best efforts to avoid raising duplicative issues.

- A. The School District's current and future operating budgets and its ability to incorporate rate increases given already substantial deficits in that funding.
- B. PGW's current collection practices and their effects upon the School District.
- C. The financial and operational effects of the rate increases upon the School District.
- D. The rationale used by PGW in assigning various School District accounts to their current rate classes.
- E. PGW's cost overruns in distribution replacement and transportation costs.
- F. PGW's activities and representations in connection with the potential sale of the company, the reasons for the lack of competition within the Philadelphia market among third-party suppliers and the results of PGW's joint_venture with other energy infrastructure providers.
- G. The performance and cost of PGW's operating plants and field service operations.

III. Witnesses

The School District intends to present direct, rebuttal and surrebuttal testimony, as may be necessary, of its witnesses. The witnesses' initial direct testimony will be in verified written form, accompanied by necessary exhibits. It is currently expected that the School District may call the following witnesses, subject to supplementation should the School District find it necessary (and upon appropriate notice to the parties, the Administrative Law Judges, and/or other interested entities):

Paul G. Vallas, Chief Executive Officer. Mr. Vallas' testimony will likely relate to the financial challenges currently facing the School District and the impact of rate increases upon the School District's students, staff, and others who use School District facilities for community programs.

Folasade A. Olanipekun-Lewis, Chief Financial Officer. Ms. Olanipekun-Lewis will offer testimony regarding the School District's natural gas consumption and expenditures, and the impact on the School District's financial situation from the imposition of another unbudgeted and substantial increase to one of the School District's most critical budget line items.

James Lewis, Director of Facilities Management and School Services. Mr. Lewis will testify about the School District's facilities and their use of natural gas supplied by PGW. He will also authenticate business records of the School District, if necessary.

Judith L. Mondre and Peter D. Burns, Mondre Energy, Inc. Ms. Mondre and/or Mr. Burns will testify regarding the projected effects of the rate increases upon the School District and the results of their analysis of PGW's stated justifications for its rate increases.

These witnesses may be reached at the contact information for counsel.

V. Discovery/Procedural Rules/Scheduling

The School District intends to comply with the discovery schedule and procedural rules announced by the ALJs during the pre-hearing conference on March 2, 2007.

V. Settlement

The School District is willing to enter into discussions with PGW to attempt to resolve this matter through settlement. If such discussions fail to produce an acceptable resolution, however, the School District is prepared to litigate this proceeding.
