
In the above-referenced Petition filed on May 28, 2015, Duquesne Light Company (“Duquesne Light” or the “Company”) proposed to file quarterly updates (within 30 days after the end of each quarter) providing a status update regarding the status of each milestone set forth in the Petition, and the Commission required the Company to file such updates as further provided in the Order issued today in the above-referenced proceeding.

This is the first quarterly update provided under the Petition. As of July 30, 2015, Duquesne Light is on schedule to meet the milestones set forth in Exhibit B to the Petition, Planned Milestones by Quarter for Regulatory Initiatives. The Company is also on schedule to implement the five regulatory requirements as set forth in the Order. Duquesne Light notes that it has eliminated the 2.4 upgrade (release 3.2 in Exhibit A of the Petition) to reduce the risk of delays in future releases. In lieu of the 2.4 upgrade, the Company plans to implement a future upgrade (2.5.2) when it is released by Oracle. The Company does not believe that the elimination of release 2.4 will impact its ability to meet the milestones set forth in Exhibit B to the Petition.


