Response:

UGI Energy Services, LLC d/b/a/ UGI EnergyLink (“UGIES”) is still awaiting the Pennsylvania Department of Revenue Tax Status Letter to supplement its Petition for Reduction in Bonding Requirement.

In response to the above June 1, 2015 TUS Data Request, UGI Energy Services, LLC d/b/a/ UGI EnergyLink (“UGIES”) submitted a request to the Pennsylvania Department of Revenue (“DOR”) to obtain a Tax Status Letter. Upon contacting DOR regarding the Tax Status Letter, UGIES was informed that DOR was unable to locate its request. UGIES resubmitted its request on July 21, 2015. Upon receipt of the second request, DOR informed UGIES that there were apparent deficiencies in UGIES’s state tax accounts that precluded DOR from issuing the Tax Status Letter.

A UGIES internal review determined that UGIES has no outstanding state tax liabilities and that the identified account “deficiencies” relate to UGIES’s 2013 change in corporate structure from a Pennsylvania corporation to a limited liability company. This change in corporate structure was previously reported to DOR and UGIES had requested that DOR update its accounts with the new corporate name and for applicable funds to be moved to the LLC. DOR is providing UGIES the opportunity to provide supporting documentation to correct the errors in DOR’s records. UGIES believes that any outstanding inconsistencies in DOR’s records will be corrected and a Tax Status Letter obtained within the next few weeks, at which time UGIES will file a supplemental Data Request Response with the Tax Status Letter.


