
Re: Advance Notice – Rate Change – Commonwealth Telephone Company

Dear Secretary McNulty:

Pursuant to the provisions of its Alternative Regulation and Network Modernization Plan, approved by the Pennsylvania Public Utility Commission at Docket No. P-00961024, Commonwealth Telephone Company (CTCo) respectfully informs the Commission that on or after February 1, 2007, it will submit a tariff change seeking an increase in CTCo's local service (dial tone) rates and other tariffed rates. It is estimated that the proposed changes will produce additional annualized revenue not to exceed \$4.92 million. The filing will be made consistent with CTCo's annual Price Stability Index/Service Price Index filing, due to the Commission on February 1, 2007.
