Dear Ms. Chiavetta,

I recently received a notice that a fine of \$600.00 has been assessed to my company because of an incident that happened 16 months ago.

I was assessed this fine for not responding to a notice that the PUC had not received my company's certification of insurance.

My auto insurance renews March 15 of each year. My insurance carrier submitted the form "E" on March 14, 2014 (copy enclosed) one day before our coverage renewed. The PUC rejected the form "E" because it was issued for "Frankford Limousine" instead of "Frankford Limousine Service Inc."

I was notified in a letter dated April 26, 2014 that the PUC rejected the form "E" because the business name did not match exactly and I immediately contacted my insurance carrier and they submitted a corrected form "E" on April 28, 2014.

I would think that correcting the insurance certificate in a timely manner and having our insurance on file would have satisfied the PUC and this matter would be closed. I see that I was wrong.

I am asking that you reconsider the \$600.00 fine against my company.

My company never had a lapse in insurance coverage. The form "E" was filed on time. The insurance carrier inadvertently shortened the name on the form but corrected the mistake immediately upon notification.

I did respond to the PUC notice by filing the corrected form "E" on April 28, 2014.

Ultimately this all stems from my insurance carrier not having "Service, Inc." on our form "E" I did what I could when I was notified and got the situation corrected.

I think a \$600.00 is not justified and I respectfully ask that the fine be dismissed.

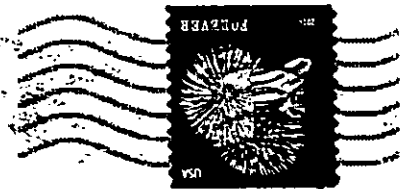
