

MOTION FOR CONTINUANCE OF HEARING

Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works, the Respondent (PGW or the “Company”) hereby requests a continuance of the hearing in this matter scheduled for 10:00 a.m., Tuesday, August 18, 2015, as there has been a change in counsel, who will be unavailable at the scheduled hearing time. In support of its motion, PGW states as follows:

1. On or about May 6, 2015, the Commission served the Respondent, PGW with the Complaint filed in the above captioned matter, to which PGW filed an Answer on May 26, 2015
2. By Notice dated July 22, 2015, the Commission scheduled an In Person Hearing in this matter for Tuesday, August 18, 2015 at 10:00 a.m., before Administrative Law Judge Angela T. Jones, in the Commission’s Philadelphia office.
3. On July 28, 2015, Michael P. Decktor, Esq., filed an Entry of Appearance in this to matter, in order to represent PGW at the August 18, 2015 scheduled hearing instead of the undersigned original Counsel of Record who is scheduled to be on vacation and out of the country until August 25, 2015.
4. As Mr. Decktor is no longer with the Company, the undersigned Counsel of Record intends to represent PGW at the hearing of this matter but will be unavailable on August 18, 2015 to do so for the reasons stated in Paragraph 3 above.
5. On August 12, 2015, PGW contacted the Complainant, Ms. Salvi concerning PGW’s request for a continuance. Ms. Salvi has indicated that she does not object to this request for a continuance of the hearing of this matter and inquired about the possibility of rescheduling the matter as a telephonic hearing to which PGW responded that she could make such a request and that it did not object to that request.

6. PGW has not previously requested a continuance in this matter.

7. Pursuant to 52 Pa. Code § 1.15(b), PGW has shown good cause for the grant of a continuance in this matter.

WHEREFORE, PGW requests that the Initial Hearing scheduled for August 18, 2015 at 10:00 a.m., in the above captioned matter be continued and rescheduled.
