RULES AND REGULATIONS

Advance Reservations:

Reservations must be made with the carrier prior to service being rendered.

Hourly Rates:

Rates begin from the time the vehicle leaves the carrier's place of business and ends at the time vehicle returns to carrier's place of business.

Holiday Rates:

Service provided during the following holidays will be assessed at \$20.00 of the published charge: New Year's Eve, New Year's Day, Christmas Eve, Christmas Day, Valentine's Day, Easter Day, Memorial Day, Independence Day, Labor Day, and Thanksgiving.

Driver Gratuity:

15% gratuity will be added on all fares.

Additional Expenses:

1. Early Morning Service:

Carrier will add an additional \$30.00 charge to any reservation that will involve transportation between the hours 12:00 AM to 6 AM.

2. All tolls, parking, fees, and out-of-pocket expense will be the responsibility of the customer and added to the carrier's charges.

3. Transportation of Animals:

Animals will not be transported unless properly secured in adequate kennel case or container. Such transportation may be refused. Service dogs for individuals with disabilities will be transported at no additional charge.

RULES AND REGULATIONS

Refusal to Transport:

Carrier reserves the right to refuse transportation to person(s) under the influence of intoxicating liquor and/ or drugs, or who, in the opinion of carrier employee, are incapable of caring for themselves or those whose conduct is likely to become objectionable to other passenger or jeopardize the movement of the vehicle. The rule does not apply to persons who are ill and accompanied by an attendant or nurse.

Hazardous or Potentially Dangerous Circumstances:

In the interest of safety of passengers, the driver, and the vehicle, the carrier reserves the right, for good cause to refuse to book or contract for a movement. The carrier shall not be responsible for:

- (1) Cancellation of a planned movement or;
- (2) Refusal of its driver to operate a vehicle on a movement in its entirety, or over part of its planned routing, under the conditions and situations set forth below, and the right is reserved for the driver alone to be the judge of such circumstances when encountered while the movement is in route:
 - (a) Hazardous or dangerous roads, driveways, bridges, parking areas, campsites, private grounds, etc.
 - (b) A picketed or forbidden place or any place under situation where violence or rioting exists, is threatened, or reasonably may be anticipated.

The carrier will, however, when practical, attempt to cooperate with the charter party in revising the routing so as to avoid any circumstance described above when encountered while movement is en route.



RULES AND REGULATIONS

Liability:

Carrier will not be held responsible for any accident or injury involving carrier's property due to the negligence of the customer or their guest(s). Furthermore, if alcoholic beverages or contraband, legal or illegal, are present within this carrier's property during the performance of the transportation service, carrier will not be held responsible for any injury or property damages due to carelessness or intentional conduct of the customer or their guest(s) in the consumption of alcoholic beverages or use of contraband involving either the carrier's or customer's property. Customer will reimburse and compensate this carrier for any damage done to carrier's vehicle or additional incidental property owned or in the possession of this carrier in the performance of the transportation service due to the negligence or intentional conduct of the customer or their guest(s). Said damages to carrier's property shall be based upon the replacement cost to said property subsequent to the initiation of repairs therein.

Claims:

Except as might otherwise be prescribed by law, all claims of whatever character must be filed in writing within (30) days with the carrier. Carrier will not be liable for delays caused by Acts of God, accidents, breakdowns, bad conditions of the road, snowstorms, or other conditions beyond its control, and does not guarantee to arrive at or depart from any point as specific time.

Promotional Fares:

Upon presentation of dated advertised coupon, carrier will offer rates at a specified discount from the published tariff rates, on the dates authorized by the coupon will be filed with the P.U.C. prior to the newspaper publication.

RULES AND REGULATIONS

Deposits and Cancellation Policy:

All reservations require a deposit of 20%. Deposits are subject to forfeiture of 50% if trip is cancelled more than 15 days but less than 30 days prior to the trip, and forfeiture of the total amount if cancelled 15 days or less prior to the trip.

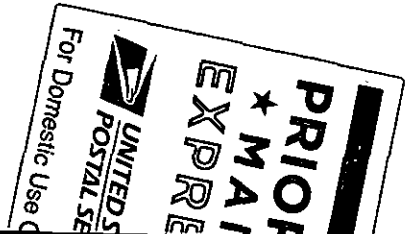
