

To transport, as a Common Carrier, persons in Limousine Service, between points in the Counties of Indiana, Bedford, and Huntington, and from points in said county, to points in Pennsylvania, and return;

### **A-00107235, F. 2, Am-A**

To transport, as a Common Carrier, persons in Limousine Service, between points in the counties of Somerset, Cambria and Fayette, and from points in said counties, to points in the counties of Allegheny and Westmoreland and vice versa.

## **RULES AND REGULATIONS**

### **Rule No. 1. - Advance Reservations**

Advance reservation required prior to pick up.

### **Rule No. 2. - Minimum Charge**

The minimum charge shall be paid at the time reservations are made.

### **Rule No. 3. - Hourly Rate**

Time starts and ends with leaving and returning to terminal.

### **Rule No. 4. - Toll and Parking Charges, Etc.**

The charges named herein do not include highway, bridge, tunnel, ferry, and parking charges. These charges shall be paid by passengers.

### **(C) Rule No. 5. - Holidays**

Customers will be charged 15% above the published fee for services provided during the following holidays: New Year's Day, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Eve, Christmas Day.

(Continued)

### **(C) Rule No. 6. - Deposits and Cancellation Policy**

Reservations are finalized upon receipt of a signed contract and a down payment of fifty percent (50%) of the base cost. Deposits are only refundable in full if canceled in excess of thirty (30) days. If canceled within fifteen to thirty days (15-30) Deposits are non-refundable if canceled within less than thirty (30) days prior to reservation. If canceled within fourteen (14) days prior to reservation client will be billed for the full rental price.

### **(C) Rule No. 8. - Promotional Fares**

Upon presentation of advertising coupons or special promotional offers, the carrier will offer rates at a specified discount from the published Tariff rates on dates authorized by the coupon or special promotional offer. The advertised coupon or promotional offer will be filed with the Public Utility commission prior to publication and/or broadcast. Coupons will be published, and promotional offers will be broadcasted in one or all of the following manners: local newspaper, fliers and other types of printed media, trade shows, conventions and all forms of radio and television advertising including the Internet.

### **(C) Rule No. 9. - Additional, Potential Charges**

Customers may be charged an additional fee between \$200.00 and \$400.00 for any cleanup of smoking, spillage, excessive mess, bodily fluid and/or vomit. The cost would depend on the nature and extent of the cleanup. In Addition, damage will be billed on a case by case basis as per replacement and repair costs; to include all burns, rips, tears, or damages to the television, stereo or other equipment and a fee of \$15.00 for any broken or missing beverage glasses.

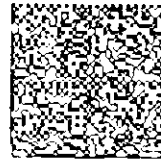
