To Whom It May Concern:

I am writing regarding a complaint issued July 18, 2014 against our company here at Leighow Oil Co Inc. On July 1, 2014 we had changed our insurance carrier as our prior years' insurance had just expired. Our new broker was Eastern Insurance Group out of Wilkes-Barre PA. Before we renewed I had addressed the issue of Cargo Insurance with our contact David Snow from that company. I received a complaint letter, with the docket number listed above, dated July 18, 2014 that our PUC operating authority had been suspended. I was frustrated as this was discussed prior to our insurance renewal. At this point, I emailed David and he said stated "the carrier had been informed upon binding coverage" that this was needed. David Snow had his office file the two forms-Form E & Form H on August 7, 2014. The first page of the complaint states- WHEREFORE, unless respondent pay the penalty of \$500 or files an answer in compliance with the attached notice AND/OR causes its insurer to file evidence of insurance with this Commission within 20 days..... Since I knew the insurance company had filed the two forms within the 20 day time frame, I felt this was completed.

On August 6, 2015 I receive another letter stating that we own a fine of \$500 for the above complaint against Leighow Oil Co Inc. I spoke with Tatiana at the PUC and she told me that since this was last year we would have to pay the fine as there was nothing that could be done. My insurance broker also spoke with the PUC and was instructed to have me address the complaint and it would be reviewed by the
