

HIKO Energy, LLC (“HIKO”) submits this Certificate of Satisfaction pursuant to 52 Pa. Code § 5.24(b), stating that the Formal Complaint filed by Ayodele Tayo with the Pennsylvania Public Utility Commission and docketed at Docket No. C-2015-2483059 has been fully satisfied and the Complainant has acknowledged to HIKO that Complainant no longer wishes to pursue the Formal Complaint.



In addition, HIKO has reached a global settlement in principle in two class actions on behalf of HIKO's Pennsylvania customers (former and current) in *Kantor v. HIKO Energy, LLC*, Docket No. 14-cv-05585-TJS (E.D. Pa.) and *Bogdanski v. HIKO Energy, LLC*, Docket No. 15-cv-02024-VB (S.D.N.Y.) and expects to finalize the formal Settlement Agreement and Notice Plan for formal approval by mid-September. Complainant is welcome to contact HIKO's counsel, Ginene A. Lewis at 215.988.2707 for further updates on the completion of settlement.

In light of the foregoing, the Commission should treat this Complaint withdrawn in accordance with 52 Pa. Code § 5.24(b), unless Complainant objects within ten (10) days of this filing.
