

Advance Reservations

Advance reservations must be made prior to the service being rendered.

Hourly Rates

Hourly rates begin from the time of pick-up and end at the time of drop-off

Holiday Rates

Service provided during the following holidays will be assessed at 25% of the published charge: New Year's Eve, New Year's Day, Christmas Eve, Christmas Day, Independence Day (fourth of July) and Thanksgiving.

Driver Gratuity

A 15% gratuity will be assessed on all fares included herein

Additional Expenses

All tolls, parking fees and other out-of-pocket expenses will be the responsibility of the customer and added to the carrier's charges.

Promotional Fares

Upon presentation of advertising coupons or special promotional offer, carrier will offer rates at specified discounts from the published tariff rates on dates authorized by the coupon or special offer. The advertised coupon or special offer will be filed with the PA PUC prior to publication or broadcast. Coupons will be published and promotional offers will be presented in one or all of the following media: Local newspapers, flyers, radio, television and internet.

Deposits and Cancellation Policy

All reservations require a deposit of 20%. Deposits are subject to forfeiture of 50% if trip is cancelled more than 15 days but less than 30 days prior to the trip, and forfeiture of the total amount if cancelled 15 days or less prior to the trip.
