This letter is in regards to the Formal Complaint, Docket No. C-2015-2469134, filed by Michael Rizzo ("Customer") and received by Public Power, LLC ("Public Power") on March 2, 2015. Public Power submitted an Answer to Customer's Complaint on March 20, 2015 explaining our position.

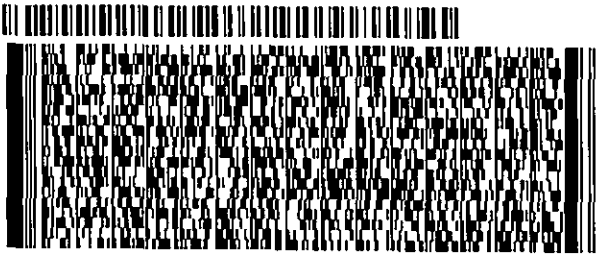

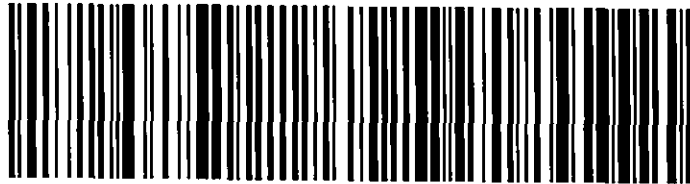
