Dear Secretary Chiavetta:

On December 12, 2014, Sharon Laffey (Complainant) filed a Formal Complaint against Knox Energy Cooperative Association, Inc. (Knox) alleging that there was a partially-exposed gas line on her property. Ms. Laffey believed that this created a hazardous condition and requested that the Pennsylvania Public Utility Commission (Commission) direct Knox to bury the gas line. In its Answer and New Matter filed on February 5, 2015, Knox stated that it was working with the Complainant to relocate and bury the service line. By Order entered September 3, 2015, the Commission encouraged the parties to file a Certificate of Satisfaction, 52 Pa. Code § 5.24, if this issue was resolved. Furthermore, the Commission remanded this matter to the Office of Administrative Law Judge and referred it to the Bureau of Investigation and Enforcement (I&E) to contact the parties and conduct an investigation into the Complainant's allegations.

On September 4, 2015, a Certificate of Satisfaction executed by the Complainant was filed with the Secretary's Bureau. Therein, Ms. Laffey certified that the Formal Complaint filed against Knox has been satisfied and requested that the Complaint be marked as withdrawn and the Commission's file closed. Additionally, on August 28, 2015, Ralph Graeser, Gas Safety Supervisor, spoke with Ms. Laffey and learned that Knox replaced the exposed service and buried the pipe underground. Accordingly, no further investigation is required by I&E at this time.


