Dear Secretary McNulty:

Enclosed for Public Utility Commission ("Commission") approval are an original and three copies of Duquesne Light Company's ("Duquesne's") quarterly updated retail rates for fixed price ("FPS") provider of last resort ("POLR") service to its large commercial and industrial customers ("Large C&I Customers") to be effective September 1, 2005. Pursuant to the Commission's Order entered in this proceeding on October 1, 2004 ("the Compliance Order"), Duquesne is required to submit for approval the results of refreshed energy price bids, and the retail rates resulting from those bids, from the suppliers providing the energy for Duquesne's FPS POLR service to its Large C&I Customers. The energy price bids and resulting retail rates were to be updated on February 1, 2005, then each quarter thereafter beginning on June 1, 2005. The enclosed retail rates are available for customers electing FPS POLR service during the Fourth Price Application Period as defined in Rider No. 8 of the retail tariff.

It is important to note that if the retail rates filed herein for the quarter beginning September 1, 2005 are not approved by the Commission by Secretarial Letter entered on or before Wednesday, August 24, 2005, these binding firm offers by the winning suppliers will terminate and no new FPS service will be available for customers that elect POLR service during that quarter.

Consistent with the Commission's Compliance Order at pages 42-43, Duquesne requests that the Secretary treat Schedule 3 of this filing as proprietary and confidential and place it in a confidential file not subject to public inspection. Duquesne has provided three copies of this schedule in a sealed envelope to be placed in a non-public file.
