

NOTE 1 - MINIMUM TRANSPORTATION CHARGES:

- Other than Sundays and Holidays: 4 hours at rates named in Columns 1 and 3 or 4.
- Sundays: 8 hours at rates named in Columns 1 and 2.
- Saturdays: 8 hours at rates named in Columns 1 and 4.
- Holidays: 8 hours at rates named in Columns 1 and 5.

NOTE 2 - For shipments originating and destined to points within Bucks, Chester, Delaware, Montgomery and Philadelphia Counties, the following travel charges will apply when distance from:

- (1) Origin and destination within 16 miles of carrier's terminal - 1 hour at the applicable rates.
- (2) Origin or destination is between 17 and 25 miles of carrier's terminal - 1.5 hours at the applicable rates.
- (3) Origin or destination is between 26 and 40 miles of carrier's terminal - 2 hours at the applicable rates.

NOTE 3 - Rates named in Columns 2, 3, 4 and 5 apply only to 12:00 Midnight. After Midnight, rates for the next day are applicable.



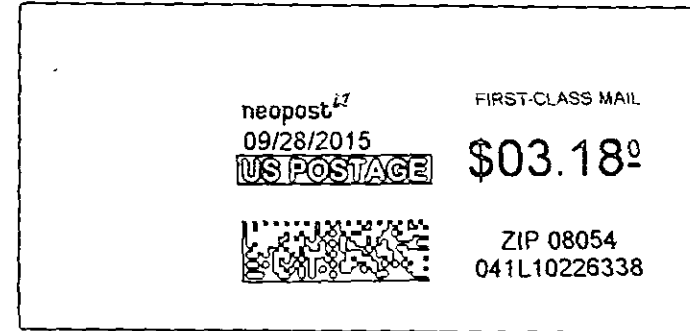
