

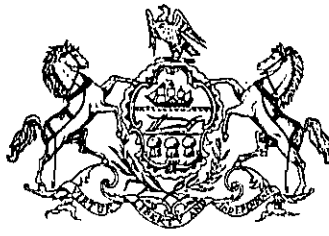

I am writing to officially file my denial of WestPenn Power Company's Answer and New Matter to my request for payment for damages caused by a power surge on May 25, 2015.

Though the outage and surge that occurred was unforeseen and unplanned, it was still an equipment failure that caused thousands of dollars of damage to my home and to the surrounding community.


The equipment that failed is owned and operated by WestPenn Power Company, therefore, WestPenn Power Company should be responsible for any damages due to that failure.

The company claims that they are not "liable for any damages due to accident, strike, storm, lightning, riot, fire, flood, legal process, state or municipal interference, or any other cause beyond the Company's control." This failure **was not** beyond control. I contest that "unforeseen and unplanned" does not mean a situation is beyond control. Decent equipment with decent maintenance could prevent this from happening. This was no act of God. This was a piece of equipment that failed and literally burned a home to the ground.

My neighbors and I do not have a choice in our power company. We refuse to let a multi-million dollar business, which we have no choice in if we want electric in our homes, bully us, force thousands of dollars out of our pockets, and create increases in our home insurance rates.

Thank you for your attention to this matter and I look forward to pleading my case further.
