Dear Secretary Chiavetta:

Pursuant to Duquesne Light Company's (Company) Distribution Rate Case Settlement in the above referenced docket, the Company committed "to spend \$15 million on distribution system vegetation management on a twelve-month basis for three years commencing May 1, 2014; provided that any shortfall below that level of spending on a twelve-month basis shall be expended no later than April 30, 2017". The first report is required to be filed with the Commission by October 31, 2015 with copies to the Bureau of Investigation and Enforcement, Office of Consumer Advocate and Office of Small Business Advocate.

For the first twelve month period, May 1, 2014 through April 30, 2015, the Company's actual vegetation management spend was \$15.6 million.






