

To transport, as a common carrier, by motor vehicle, persons in group and party service, in vehicles seating eleven (11) to fifteen (15) passengers, including the driver, from points in the counties of Blair, Cameron, Centre, Clarion, and Clearfield to points in Pennsylvania and return; excluding areas under the jurisdiction of the Philadelphia Parking Authority.

Rules

Initial Deposit: A \$200.00 refundable deposit, per limousine, is required to guarantee the requested date and time. The deposit is due: UPON RECEIPT

This is a first-come, first-served policy. The deposit is required IN ADDITION TO the rental charges, which are based on your estimated time involved. The deposit will be returned to you less any: a) cancellation fees; b) excess time charges; c) damage/cleaning charges; or d) chauffeur's gratuity. Any paid but unused rental charges will also be returned to you.

FULLINGTON VIP LIMOUSINE WILL SUPPLY NO ALCOHOLIC BEVERAGES.

DRUG AND ALCOHOL POLICY:

Drug and alcohol use may pose a serious threat to the health and safety of our passengers and may involve violations of the law. Consequently, Fullington VIP Limousine has adopted the following policy: **Alcohol:** Any alcohol must be consumed in a responsible manner. Alcohol use is strictly prohibited in our vehicles by anyone under 21 years of age. **Drugs:** Illegal drug use will not be permitted for persons of any age in our vehicles. Person whose name appears on the contract is responsible for all persons in their party. The chauffeur, in his or her sole discretion, may refuse to allow any person who is visibly under the influence of either drugs or alcohol to enter the vehicle. If any passengers violate this policy, as determined in the chauffeur's sole discretion.

Rental Payments: Payment may be made using cash, check, credit card or money order. Returned checks will incur a \$20.00 service fee.

Payment in full is due: TWO WEEKS PRIOR TO SERVICE DATE

Cancellations and Refunds: This policy will apply regardless of the reason for cancellation. Cancellation fees apply whether or not a customer changes to or is rebooked on another date.

Over 60 days in advance of service date: 100% refund

14-59 days in advance of service date: 50% refund

1-13 days in advance of service date: No refund

NOTE: Cancellation fees apply only to the initial deposit fee. If you pay any rental fee and then cancel, the rental fee will be returned to you in full.

Damage: The undersigned shall be held liable for any damage to the interior or exterior of the limousine/trolley, caused by negligence on the part of the undersigned or any member of the undersigned or any member of the undersigned's party.

Smoking is NOT permitted in the limousine.

Liabilities: In the event of unforeseen Acts of God and/or mechanical failure of the limousine which prevent Fullington VIP Limousine from fulfilling its part of the contract, we agree to provide alternative transportation. Charges will be adjusted accordingly. Fullington VIP Limousine will reimburse up to the total cost of the contracted rate, subject to our discretion.

Promotional Fares: Upon presentation of advertising or special promotion offer, carrier may offer rates at specified discount from the published tariff rates on dates authorized by the coupon or special offer.
