In accordance with 52 Pa. Code § 54.34, Champion Energy Services, LLC (“Champion”) hereby notifies the Pennsylvania Public Utility (“Commission”) of a change in its corporate ownership structure related to its electric generation supplier (“EGS”) license issued in Docket No. A-2009-2124113.

Champion is wholly-owned by Champion Energy Marketing LLC (“Champion Marketing”). On or about October 1, 2015, Calpine Energy Services Holdco LLC (“Calpine”) directly acquired all of the membership interests of Champion Marketing. A chart depicting the new ownership structure is attached hereto as Attachment A. Additionally, an updated list of officers and directors is attached hereto as Attachment B.

Champion anticipates that the change in ownership of its parent company, Champion Marketing, will have no effect on Champion’s continued operation, current contracts, provision of service, or any other aspect of Champion’s operation in Pennsylvania.

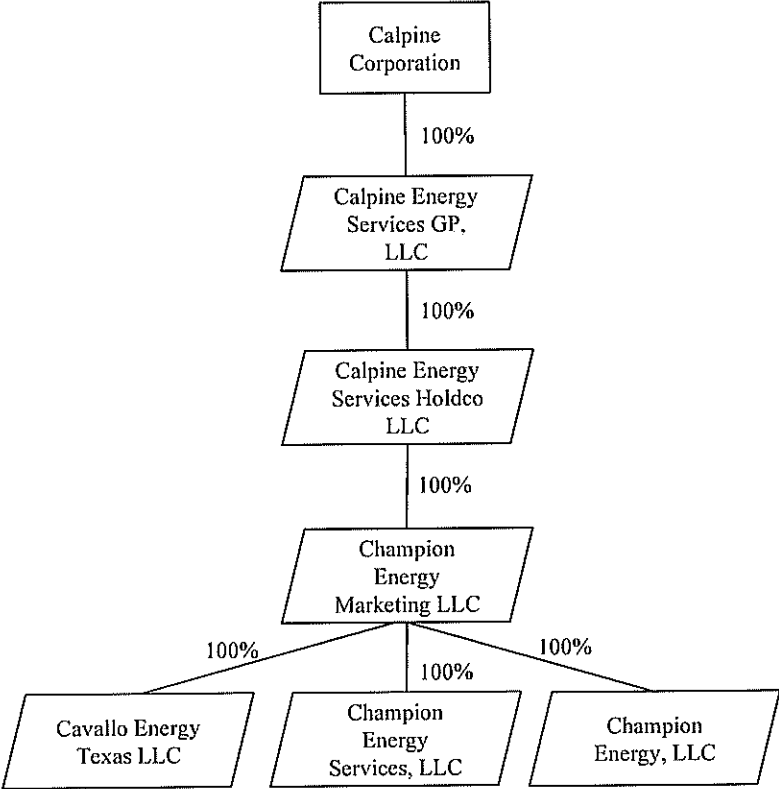
