Dear Judge Coccheres:

The above matter is scheduled for a telephonic hearing on December 15, 2005 at 10:00. I am writing to respectfully request a postponement of one month for the following reason. Our son is currently a freshman away at college. He was recently diagnosed with a serious bowel disease; though we believed he was headed for remission he is now sick and bleeding again. He is anemic. We are trying to bring his condition under control and this is hampered by his being away at college. The hearing is scheduled right when he will be taking his final exams and preparing to return to PA. My plan given my son's most recent state is to be in VA during that week to assist him with his special food preparation, see his specialist before holiday break, and transport him home for the holidays. If it is at all possible I would ask that the court grant us a one month postponement so that I may be with my son that week without distractions. (To participate by phone from VA would be difficult as my witness will be in PA and I would prefer to have him with me when he testifies; I would also like to be able to take care of Andrew, without distraction, when he will especially need it given his illness and the additional stress his body is likely to undergo during final exams.)

Please advise; thank you for your anticipated consideration.


Dear Judge Cocheres:
