Weekdays 8:00AM to 5:00PM: 3 hours at rates named in Column 3 plus applicable travel charge.

NOTE 2 - When a holiday falls on a Saturday, rates named in Columns 1 and 2 shall be applicable.

NOTE 3 - Rates named in Columns 3 and 4 apply from 8:00AM to 12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE AA - (1) One (1) hour travel charged for up to 25 miles from carrier's terminal (17552 zip code).
 (2) One-half (1/2) hour charge per additional 25 mile increment, or fraction thereof.
 (3) Mileage to be determined by Google Maps Zip Code to Zip Code.
 (4) Hourly charge will be based on the hourly rate for how many movers and vans travel to the origin job site.
