

Please be advised that Duke Energy Retail Sales, LLC, a licensed Electric Generation Supplier ("EGS") in Pennsylvania, has been renamed as Dynegy Energy Services (East), LLC. As you may know, Dynegy Inc. acquired this licensed Electric Generation Supplier as part of a transaction that closed in April 2015.

The Commission approved this name change for purposes of the EGS license in Docket No. A-2010-2199236¹, and issued an amended license reflecting the new name on September 30, 2015 via a Secretarial letter.
