responds to the answer and states:


1. Admitted.

The customer charge is separate from the customer's distribution or generation charges. By way of further answer, PECO Energy avers that the references made by Complainant to the lists of electric choice terms included on his bill does not indicate that the customer charge is a duplicate. The terms listed on the bill itemize the charges that may appear on the bill.

Honorable Commission dismiss the instant Complaint.


