ON THE RESOLUTION CONFERENCE HELD ON THE ABOVE-DOCKETED MATTER


This report is prepared in accordance with the Honorable Veronica A. Smith's December 20, 2005 Interim Order Setting Resolution Conference. As instructed therein, Ms. Deborah Gardner, Customer Relations Representative for The Peoples Natural Gas Company d/b/a Dominion Peoples, contacted Complainant and made arrangements to conduct a January 9, 2006, telephonic conference at 10:00 a.m. On the aforesaid date and time, I contacted Complainant telephonically, Ms. Gardner joined me in my office and the three of us proceeded to discuss the above-docketed complaint. As a result of the fruitful exchange which took place among the participants, I am pleased to report that a full settlement has been achieved and that Complainant has agreed to withdraw the formal complaint against Dominion Peoples. Specifically, Dominion Peoples agreed to correct Complainant's natural gas service account statement for 310 Station Street, Apt. # 2B, Imperial, PA 15216 to reflect a zero account balance as of August 31, 2004.

As a way of amicably disposing of this matter before the Commission, I enclose
