PECO Energy Company ("PECO Energy"), pursuant to 52 Pa. Code §5.61, responds to the Complaint and states:

- 4. Admitted in part and denied in part. PECO Energy admits that it was necessary to

remove and replace the gas meter at Complainant's property. It is also admitted that Complainant's gas bill was estimated for the period of February 16, 2005 through January 19, 2006; however, it is specifically denied that PECO Energy has not resolved the metering issue and made the requisite billing adjustments.


On January 26, 2006, PECO Energy did remove the gas meter at Complainant's property and installed a new meter. The gas usage was estimated for service during the period of February 16, 2005 to January 19, 2006. The actual/estimated billed gas usage for the period of February 17, 2004 to February 16, 2005 was 875 ccfs. The actual/estimated billed usage from February 16, 2005 to February 16, 2006 was 913 ccfs for a total difference of 38 ccfs. PECO Energy did not bill gas usage from January 19, 2006 to January 26, 2006.

A decision by the Bureau of Consumer Services ("BCS") issued on March 8, 2006 that the estimated bills were in line with prior usage, and actual meter readings will be used for billing going forward. A copy of the BCS decision is attached as Exhibit A.

5. This paragraph is a request for relief and no answer is required.
6. PECO Energy is without sufficient information to confirm or deny this statement.
7. Admitted.

**WHEREFORE**, PECO Energy Company respectfully requests that your Honorable Commission dismiss the instant Complaint.




