

1. Admitted. PECO Energy avers that the ratepayer for this property is listed

3. Admitted in part and denied in part. PECO Energy admits it provides  
electric service to this property. PECO Energy denies it provides gas service to this  
property.

4. Admitted in part and denied in part. PECO Energy admits that the unpaid  
charges from the ratepayer, Dara Feinstein's, account at 8003 Ivy Lane, Elkins Park, PA  
were applied to the ratepayer, Dara Feinstein's, current account at 310 Bickley Road,  
Glenside, PA. PECO Energy denies those charges are improper; PECO Energy denies  
there are any safety or reliability problems with service to this property.

PECO Energy also denies that proper notice was not given prior to the  
service termination on June 13, 2005. PECO's records indicate a 10-day notice was  
issued on May 27, 2005 for the past due amount on the account of \$1,332.49 with a  
termination date on or after June 10, 2005. Telephone attempts were made on June 1,

2005 at 7:44 p.m. and then on June 2, 2005 at 10:15 a.m.; there was no answer on both attempts. Service was terminated at this property on June 13, 2005, after contact was made at the property. Due to the termination without direct access permission, PECO Energy credited the reconnection fee of \$120.00 to the customer.

5. This paragraph is a request for relief and no answer is required.

6. PECO Energy is without sufficient information to confirm or deny this statement.

7. Admitted.

**WHEREFORE**, PECO Energy Company respectfully requests that your Honorable Commission dismiss the instant Complaint.




