On behalf of Choice Energy, LLC d/b/a 4 Choice Energy (“Choice”), and pursuant to 52 Pa. Code § 54.34, we are providing additional materials to the Pennsylvania Public Utility Commission (“PUC”) to update Choice’s previously approved license application and to supplement my June 8, 2015 correspondence. 

FINAL ORDER OF DISMISSAL


The Court having been advised by the parties that this civil action has been settled;

IT IS SO ORDERED.

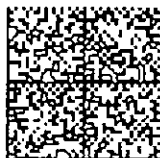
