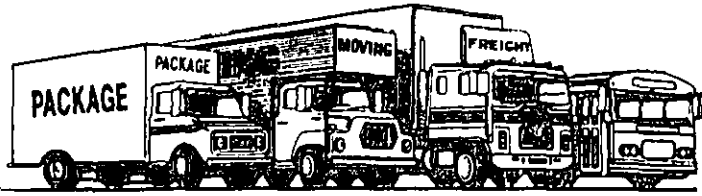


Two (2) copies should be forwarded to Mr. Robert Bingaman, Compliance Manager, Bureau of Technical Utility Services and one (1) copy to the Secretary's staff for information and scanning.

Also attached is a signed letter for 2014 that the operating ratio was not less than 93%.

The proposed loose-leaf revisions are seeking increases for hourly rates covering Sunday and Holiday (any hour) and Weekdays 6:01 A.M. to 5:00 P.M. Rates covering Saturday any hour and Weekdays 5:01 P.M. to 6:00 A.M. were decreased. In addition the containers and packing were increased but unpacking and containers furnished to shipper only were not changed.

The proposed loose-leaf revisions are being filed on thirty (30) days' notice and scheduled date of December 7, 2015.

SECTION 2

ADDITIONAL SERVICES

Rates and charges for Additional Services shown in this section are in addition to all other rates in this tariff. Rates and charges apply on shipments when released to a value not exceeding 60¢ per pound per article.

ITEM 200 - PACKING, UNPACKING AND CONTAINER CHARGES

1. Packing rates include only the packing service of carrier furnished containers.
2. Unpacking rates include unpacking service of containers furnished and packed by carrier and disposal of such containers and materials if requested by consignee. Unpacking service, if ordered, must be performed at time of delivery unless consignee requests otherwise. If consignee requests that unpacking of carrier packed items be performed subsequent to the time of delivery, the unpacking charges provided will apply subject to the minimum charge shown. Apply hourly rates in Item 350 herein for unpacking of all containers not packed and furnished by the carrier.
3. When delivery of containers prior to performance of transportation or pickup of containers after performance of transportation is required by shipper, charges as shown in Item 350 herein will apply.

SECTION 3  
HOURLY RATES

ITEM 350

Applicable to Class 1 shipments transported distances of forty (40) miles or less. Subject to Notes 1 to 8 below, the transportation charge on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 or 4.

Hourly rates apply only from time of arrival of vehicles and men at first point of origin (continue during all loading, transportation from first point of origin to final destination, and unloading) until completion of unloading and dismissal of vehicles and men by shipper at destination.

Traveling charges cover traveling to first point of origin and traveling from final destination, irrespective of actual time involved in such traveling.

Note 2 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 or 4).

Note 3 - Hourly rates (Columns 2, 3 and 4) are based on the day or days, or periods of days, as indicated during which services are performed.

Note 4 - Hourly rates (Columns 2, 3 and 4) computed in half-hour periods; fractions of one-half hour considered one-half hour.

Note 5 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

Note 6 - Except as otherwise applicable minimum total transportation charges on:  
Holidays and Sundays - 8 hours at rates named in Columns 1 and 2.  
Saturdays and Weekdays- 4 hours at rates named in Columns 1 and 3 or 1 and 4

Note 7 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination, unless other time of arrival or dismissal of supervisor is provided by agreement between shipper and carrier.

ITEM 350 (CONCLUDED)

(C) Note 8

A travel charge will apply on all local residential moves in an amount to be determined as follows:

When the distance from our terminal to either the origin or destination of the shipment, whichever is furthest is between 0 - 15 miles, the travel charge will be 1 hour.

When the distance from our terminal to either the origin or destination of the shipment whichever is furthest is between 16 - 20 miles, the travel charge will be 1.5 hours.

When the distance from our terminal to either the origin or destination of the shipment, whichever is furthest is between 21 - 25 miles, the travel charge will be 2 hours.

When the distance from our terminal to either the origin or destination of the shipment, whichever is furthest is between 26 - 40 miles, the travel charge will be 2.5 hours.

When the distance from our terminal to either the origin or destination of the shipment, whichever is furthest, is greater than 40 miles, the travel charge will be increased by 1/2 per each 10 mile increment.

Fractions of a mile are to be rounded to the next whole mile. For example, 15.1 miles is to be rounded up to 16 miles.
