CERTIFICATE OF SATISFACTION

1. Complainant is Anthony Cusumano, Jr.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as “PPL Electric”).
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) Complainant, Anthony Cusumano, Jr. (“Complainant”), and Respondent, PPL Electric (“Respondent”), agree that Complainant will make a payment to Respondent in the amount of \$500.00 to reconnect his electric service no later than November 30, 2015. Complainant and Respondent further agree that Respondent will restore Complainant’s electric service within twenty-four (24) hours of receipt of this payment. Complainant and Respondent further agree that Complainant will pay his regular monthly bill plus \$242.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant’s December 2015 bill due date. Complainant and Respondent further agree that Respondent will have an Ontrack customer assistance program application mailed to Complainant on November 5, 2015, which Complainant has agreed to complete and submit to his local agency as soon as possible.

Complainant and Respondent further agree that if Complainant is enrolled in the Ontrack customer assistance program, then Complainant's monthly Ontrack payment amount will override his monthly payment obligation described above.

4. (b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
