Please be advised that the Coalition for Affordable Utility Services and Energy Efficiency (CAUSE-PA) will not be filing exceptions to the Recommended Decision of Administrative Law Judge (ALJ) Angela T. Jones issued October 28, 2015.

CAUSE-PA is aware that the ALJ has recommend a modification to the provisions of Paragraph 25 (revenue decoupling) of the proposed settlement.
